FINAL READING OF ORDINANCES

Ordinance No. 26535

Amending Chapter 13.06 of the Municipal Code to reclassify the property located at 3939 South Orchard Street from a "C-1" Commercial District to an "M-1" Light Industrial District to allow the property to be used as an electrical contractor's corporate headquarters and storage use. (CTM Group #1, L.L.C.; File No. REZ99-00002)

Ordinance No. 26655

Amending Chapter 13.06 of the Municipal Code to reclassify the property located north of Sixth Avenue and on the west side of Orchard Street from an "R-2" One-Family Dwelling District to an "R-3-PRD" Planned Residential District to allow construction of a 50-unit, low-income seniors apartment building. (George A. Haddow, First Christian Church; File No. REZ99-00011)

Council Member Crowley moved to concur in the Findings, Conclusions and Recommendations of the Hearing Examiner. Seconded by Council Member Phelps. Voice vote was taken and carried. The motion was declared adopted.

The Ordinance was set over for final reading to a date to be determined.

Ordinance No. 26656

Authorizing the execution of an agreement with the United States Department of Housing and Urban Development (HUD) and its Office of Inspector General to provide for intergovernmental cooperation in HUD's Operation Safe Home Project; accepting, depositing in and appropriating \$80,000 from the Miscellaneous Grants Summary Fund; and amending the 1999-2000 Biennial Budget by said sum.

The Ordinance was set over for final reading next week.

Ordinance No. 26657

Authorizing the execution of a purchase and sale agreement with the Burlington Northern and Santa Fe Railway Company, in the amount of \$26,000, for the purchase of real property located adjacent to Dock Street, between East 15th and East 17th Streets; appropriating said sum from the Thea Foss Waterway Development Authority Summary Fund; and amending the 1999-2000 Biennial Budget.

Council Member Crowley moved that the Resolution be adopted. Seconded by Council Member McGavick. Voice vote was taken and carried, with Deputy Mayor De Forrest voting in opposition. The Resolution was declared adopted.

Resolution No. 34844

Authorizing the execution of an agreement with the City of Portland, Oregon, in the amount of \$35,000, to purchase a Records Management System for the Fire Department.

Council Member Crowley moved that the Resolution be adopted. Seconded by Council Member McGavick. Voice vote was taken and carried. The Resolution was declared adopted.

Resolution No. 34845

Designating the Fire Department Records Management System Replacement Project as a special project of limited duration.

Council Member Crowley moved that the Resolution be adopted. Seconded by Council Member McGavick. Voice vote was taken and carried. The Resolution was declared adopted.

Resolution No. 34846

Authorizing the execution of a Multi-Family Housing Limited Property Tax Exemption Agreement with Dobler Limited Partnership to construct 40 units of market rate multi-family housing at South 48th Street between Junett and Pine Streets.

Council Member Crowley moved that the Resolution be adopted. Seconded by Council Member Phelps. Voice vote was taken and carried, with Deputy Mayor De Forrest voting in opposition. The Resolution was declared adopted.

Resolution No. 34847

Authorizing the execution of a Multi-Family Housing Limited Property Tax Exemption Agreement with Dobler Limited Partnership to construct 92 units of market rate multi-family housing at South 47th and Lawrence Streets.

Council Member Crowley moved that the Resolution be adopted. Seconded by Council Member McGavick. Voice vote was taken and carried, with Deputy Mayor De Forrest voting in opposition. The Resolution was declared adopted.

PUBLIC HEARINGS AND APPEALS (Began at 5:26 p.m.)

<u>Stephen W. Fisher</u>, representing Wapato Hills Task Force, and <u>Skip Vaughn</u>, representing South Tacoma Neighborhood Council, appealing the recommendation of the Hearing Examiner regarding the request to reclassify the property located at 6050 Tacoma Mall Boulevard, from an "R-2" One-Family Dwelling District and an "R-4-T" Multiple-Family Dwelling Transitional District to a "C-2" Commercial District, to allow the development of a 24,180-square-foot, three-story office/retail building. (Arsland, Inc.; File No. REZ99-00008)

Mayor Ebersole called the quasi-judicial hearing in session and asked Council Members to disclose any personal interest or *ex parte* communications with the parties regarding this case. There were no disclosures made by members of the City Council.

Mayor Ebersole called on Mr. Rod Kerslake, Hearing Examiner.

Mayor Ebersole then called on Mr. Skip Vaughn, representing South Tacoma Neighborhood Council, and Mr. Fisher, Wapato Hills Task Force, Appellants.

Deputy Mayor De Forrest then called on Mr. Bill Lynn, representing Arsland, Inc., Respondent.

Council Member Crowley moved to concur in the Findings, Conclusions and Decision of the Hearing Examiner and deny the appeal. Seconded by Council Member Phelps.

Roll call vote was requested and taken, resulting as follows:

REPORTS BY CITY MANAGER

City Manager Ray E. Corpuz Jr. introduced Gary Kato, Source Control Supervisor, from the Solid Waste Utility, as the special assistant in the City Manager's office, for the next three months. He then thanked Ric Teasley, Tacoma Economic Development Department, for his fine job during the past three months.

COMMENTS AND COMMITTEE REPORTS OF CITY COUNCIL

Council Member Kirby inquired about preliminary budget figures currently being discussed in preparation for the 2001-2002 biennial budget. He stated that he has had several inquiries regarding the proposed budget and proposed budget cuts and requested a copy of the preliminary budget figures.

City Manager Corpuz stated that there is a \$12 million gap in the upcoming 2001-2002 biennial budget. He stated that a presentation on how the budget works, including revenue sources and the challenges facing the City, including the \$12 million figure, was discussed in a study session and has been shared with some Neighborhood Councils. Mr. Corpuz stated that more specific information is also available and can be provided. He then stated that the budget guidelines would be issued next week, which will give departments direction for constructing General Fund budgets. He stated that a budget update is scheduled for Tuesday, August 1, 2000, at the noon study session, to discuss projected revenues, conditions that might affect the budget and any suggestions or modifications made by the City Council.

Council Member Crowley moved to excuse Council Member Evans from tonight's meeting. Seconded by Council Member McGavick. Voice vote was taken and carried. The motion was declared adopted.

Council Member Crowley congratulated Bob Christopherson on his move from Stadium Manager and Head Groundskeeper at Cheney Stadium to Safeco Field.

Council Member Crowley moved for a five-minute recess. Seconded by Council Member McGavick. Voice vote was taken and carried. The motion was declared adopted.

The Council recessed at 6:16 p.m. and reconvened at 6:21 p.m.
