and by adding a new section to be designated as Section 5 to read as follows:

"Section 5. In order to insure that there will be adequate capacity within Pierce County jail facilities, and to avoid the danger to the public safety which would result from the release of inmates if the July 1, 1996, population maximum established by federal court order is not met, it is imperative that this ordinance take effect at the earliest possible date, and by reason thereof, and in accordance with RCW 35.33.081 and Section 2.12 of the Charter of the City of Tacoma, a public emergency is hereby declared to exist making necessary the immediate passage of this ordinance and its taking effect immediately upon publication."

REPORTS BY CITY MANAGER:

Ray E. Corpuz, Jr., City Manager thanked Mr. Gary Tiedeman for his work as Special Assistant in the City Manager's Office for the last three months. He then asked the City Council to let him know how to proceed regarding his recommendations on funding for the County's "Drug Court" issue. Mr. Corpuz reported that he called the Emergency Operations Center regarding the storm and that the City of Tacoma was doing generally well. There were no power outages, no fires, the Christmas tree was still standing and the wind was still blowing. He then requested an executive session not to exceed 10 minutes to consider pending litigation.

COMMENTS AND COMMITTEE REPORTS OF CITY COUNCIL:

Deputy Mayor Evans read and presented a proclamation and a plaque with the Seal of the City to Mayor Moss.

Council Member McGavick stated that Mayor Moss and her had shared many things over the years. Two of those things they shared was the same house and the same Council seat, but not at the same time. She thanked Mayor Moss for many laughs, tears, kindness, support and leadership. She called him a gentleman and a scholar and appreciated working with him and that she would miss him.

Council Member De Forrest stated that Mayor Moss exceeded Council Member Kirby with years on the City Council. He appreciated the fact that he never used the phrase "on the previous Council." He indicated that twenty-four years ago he did not vote for the Mayor and stated politically they were on the other side of the fence. However, Mayor Moss did make one bad mistake during his term in office and that was passing term limits in the City Charter. Council Member De Forrest stated that he enjoyed telling people in the community that this is the finest Mayor Tacoma has had in twenty-five years or longer. He complimented the Mayor on giving people his attention and treating everybody equal, whether you sat behind the dais, lived in the city limits or came from Bainbridge Island. He reminisced about an ordinance being discussed during a previous Council meeting, when others wanted to stop him from speaking, the Mayor did not call him out of order. He went on to state that if there was one legacy Mayor Moss should be remembered for is his serving the community, leaving it a better place and that everybody loves him.

Council Member Crowley stated that he enjoyed working with Mayor Moss the last 2 years. He stated that he knew the minute he met Mayor Moss that he was going to like him and be able to trust him and the Mayor held up to that. Council Member Crowley commented on the Mayor's speaking ability and how he envied that ability. He stated that he was disappointed that the Mayor was not nominated as one of the funniest Mayor's. He stated that he thinks the Mayor is a lot funnier than Norm Rice.

Council Member Kirby stated that he thinks it will be a long time before Tacoma has another Mayor who will be the personality and the ambassador for Tacoma that Mayor Moss has been. He stated that is Mayor Moss' gift to Tacoma. He also envied his ability to always know the right thing to say. Council Member Kirby then told a story that took place at the firefighters annual retirement dinner and about being bestowed with the honor of becoming a honorary firefighter. He indicated that he was one of the few people in Tacoma to have that honor. He continued the story stating that Mayor Moss had begged to become an honorary firefighter. He also stated that there was another honor out there to be bestowed on the Mayor and to save the Mayor from groveling he presented the Mayor with a T-shirt that said "I know Steve Kirby."

Council Member Silas thanked the Mayor for being our Mayor. She stated that this job wasn't and isn't an easy job, but he made it looked easy. She expressed her appreciation for his class, patience and letting Council Member De Forrest talk on and on until 1:00 in the morning without cutting him off, when everyone else is saying cut. She indicated that a dinner in his honor had been planned for tonight but because of the wind storm it had been postponed. Council Member Silas presented the Mayor with a gift in remembrance of this Council.

Council Member Baarsma stated that on the evening of the Mayor's appointment he had the pleasure of speaking as the unofficial resident political historian. He continued by restating some of those milestones. He stated that Mayor Moss was not the first appointed Mayor under the Council/Manager form of government that he was the fifth. He then stated that the Mayor was not the first Harold to be appointed that Harold Tollefson was the first. He continued with more milestones by stating that Mayor Moss was the first appointed Mayor to be appointed on a unanimous vote. He also noted that all the other Mayors that were appointed failed to be reappointed or reelected. He indicated that if this Council had the opportunity, they would reappoint Mayor Moss unanimously, which would have been another milestone because Mayor Moss would have been the first unanimously reappointed Mayor. He congratulated Mayor Moss on the good work he did.

Council Member Miller described Mayor Moss as one of the most decent and gracious man he has ever had the pleasure to know. He stated that Mayor Moss represented the City of Tacoma most eloquently. Council Member Miller stated that it has been a honor to serve along side Mayor Moss, and called him a very good friend. He stated that some people make significant impacts on your life and help in the direction you take, and indicated that Mayor Moss had had that affect on him.

Deputy Mayor Evans describe the Mayor as having an eloquent use of the language and patience beyond anything he has ever seen exhibited. He stated that he appreciated the way the Mayor treated people, both on the dais, in the audience and staff. He stated what a great pleasure and how gratifying it is to see the Mayor where he is today. He wished the Mayor continued progress. He also stated another milestone, Mayor Moss was the first Mayor to be married in office.

Mayor Moss stated that he is deeply appreciative of what life gives him and that transformation is a reflection of the people he has encountered. He then stated that the folks that are out there doing things and making things happen are the most fascinating people. Mayor Moss stated that he had survived a car crash and at that point he knew someone had plans for his life. He stated that he is pleased that part of those plans was serving the City of Tacoma as Mayor. He stated that it has been one of the greatest things that has happen to him. He then introduced his wife Bil Moss and recognized his mother and sister who were unable to attend tonight because of the storm. Mayor Moss stated that the City of Tacoma and the City Council are in good hands with Mayor Elect Ebersole. He stated that Mayor Elect Ebersole lead the discussion at the legislative breakfast that morning and did so with great knowledge and grace. He is going to be a great Mayor and he's glad that he supported him and watched his career over the years. Mayor Moss stated that the employees of the city have a hunger to serve the City and you can see it and he appreciated that. Mayor Moss continued by addressing Ray E. Corpuz, Jr., City Manager, has having an uncanny capacity to bring the very best out in people that work for him. He stated that Mr. Corpuz gave the City Council great confidence in his decision making capacity and in his ability to digest complex issues and get them before Council. He then reminisced about the appreciative dinner for the Committees, Boards and Commissions. He acknowledged all those that served on a Committee, Board and Commission. He ended by saying that he cherished every moment.

Mayor Moss moved to recess for 10- to 15-minutes. Seconded by Council Member De Forrest. Voice vote was taken and carried. The motion was declared adopted. The Council recessed at 8:33 p.m. and reconvened at 8:44 p.m.

Council Member De Forrest wished everyone a Merry Christmas and a Happy New Year.

Council Member Baarsma reported that last week the City Council passed a Resolution dealing with TCI's decision on Canadian Broadcasting Corporation. He indicated that he took the issue to the Rainier Cable Commission. He asked Mr. Pease to send a copy of the Resolution and the letter to Ms. Barbara Wyatt to the TCI Denver office.

On proper motion, the meeting was adjourned at 8:45 p.m.
