Joint Executive Session - Pending Litigation

MOTION: Council Member Ibsen moved to convene to a Joint Executive Session pursuant to RCW 42.30.110(1)(i) to discuss pending litigation, not to exceed 15 minutes.

The City Council and Public Utility Board (PUB) convened to a joint Executive Session at 12:09 p.m. City Attorney Bill Fosbre and Chief Deputy City Attorney Tom Morrill were present.

The joint Executive Session concluded, and the joint study session reconvened at 12:25 p.m.

Joint City Council/Public Utility Board Briefing Items

1. 19-1423 City-wide Draft Federal and State Legislative Agendas

At approximately 12:25 p.m., Anita Gallagher, Assistant to the City Manager, made opening remarks and introduced Alisa O'Hanlon, Government Relations Coordinator, City Manager's Office, Clark Mather, Community and Government Relations Manager, and Marian Dacca, State Relations Manager, Tacoma Public Utilities (TPU).

Ms. O'Hanlon presented the City-wide draft Federal and State
Legislative Agenda, including the 2020 General Government Federal Agenda,
noting affordable housing and homelessness, infrastructure, environment,
human dignity and safety, and employer-provided health care coverage.
Mr. Mather reviewed the TPU Federal Agenda, noting water, rail, and power.
Ms. Gallagher outlined the General Government state priorities, noting the
Northwest Immigrant and Customs Enforcement (ICE) Processing Center;
affordable housing and homelessness; transportation; forthcoming requests;
and the support/oppose/monitor list. Ms. Dacca presented the 2020 TPU
State agenda, noting power, water, and rail. Ms. Gallagher concluded by
reviewing the calendar and the government relations resolution.

Discussion ensued regarding the relationship between General Government and TPU, the Northwest ICE processing center, affordable housing numbers, and global changes to rentals protection code.

The joint study session was adjourned at 1:23 p.m.

The regular study session convened at 1:29 p.m., after a brief recess.

City Council Briefing Items

2. <u>19-1372</u> Proposed Local Improvement District No. 7731 Appeal Hearing

At approximately 1:30 p.m., City Attorney Bill Fosbre requested that any Council Members who had ex parte communication with any parties involved in the hearing disclose that communication before the hearing. Council Member Thoms stated he met with City staff regarding the appeal. Council Member Ibsen stated he had email communication with the applicants detailing the appeal process. They determined the communications would not cause a bias in their decision and there was no rebuttal from the appellant.

Deputy City Attorney Steve Victor made opening remarks on the appeal of the revised recommendation on request for reconsideration in formation of proposed Local Improvement District (LID) No. 7731.

Ralph Rodriguez, LID Manager, Public Works, explained the background of LID No. 7731.

Mr. Victor presented the Hearing Examiner's recommendation and introduced the appellant, Greg Duras.

Mr. Duras presented his appeal.

Discussion ensued regarding poles on the Duras property, power line placement, safety issues, the effects of the LID, the options of the appeal, how the assessments were calculated, savings in doing a joint project now versus doing the LID in the future, the scoping of the LID, and the reasoning behind the Hearing Examiner's recommendation.

MOTION: Council Member Ibsen moved to convene to Closed Session pursuant to RCW 42.30.140(2), to discuss the quasi-judicial matter, not to exceed 10 minutes.

ACTION: Voice vote was taken and carried. The motion was declared adopted.
