Fire Chief, Tony Mitchell, reviewed the technology program the Fire Department is embarked upon and the need to have an individual qualified to steer the program. He advised that future appointments to the position would be made from Fire Department personnel within the same pay range.

After discussion that groups and organizations be permitted to furnish their own food at certain gatherings in the Pavilion, it was felt that Appendix Three concerning the catering contract should at this time be removed from the regulations until a future date when the award for catering services would be considered.

Mr. Schroeder moved to remove Appendix Three. Seconded by Mr. Nielsen. Voice vote was taken and carried.

On question of Bill Pollack, Hotel, Motel & Restaurant Employees Union Local 61, Mayor Johnston advised that the catering service was not being voted upon in this resolution.

PUBLIC HEARINGS
AND APPEALS:

COMMENTS BY MEMBERS OF THE CITY COUNCIL:

Mr. Nelson advised that the meeting scheduled by the County Commissioners for tomorrow evening has been changed to April 14th at 5:30 p.m. at a location to be announced.

Mr. Hudson reported on the sub-regional meeting of the Puget Sound Council of Governments, which he attended last week and said there is now a multi-county task force, which he will be on which will be dealing with the drafting of the final resolution. He will report on it when the task force completes its work.

Mr. Warnick commented on the City Manager's memo regarding maintenance cost figures obtained from the Coast Guard on the "Swiftsure" museum proposed by the Bicentennial Commission. He said outside information passed on to him indicates the costs might be approximately 20 percent less. He asked that the City Manager look further for estimates.

Mayor Johnston moved for a brief Execution Session to discuss a personnel matter. Seconded by Mr. Schroeder. Voice vote was taken and carried. The meeting recessed at 7:20 p.m. The meeting reconvened at 7:57 p.m.

Upon proper motion, the meeting adjourned at 7:58 p.m.
