REPORTS BY CITY MANAGER:

City Manager Ray E. Corpuz, Jr. requested an Executive Session, not to exceed 30 minutes, to discuss pending and potential litigation.

Mr. Corpuz announced that the General Government's Community Connection program participated in the Paint Tacoma-Pierce County Beautiful Program by painting the home at 6516 Tacoma Avenue South. Mr. Corpuz read the names of the 24 employees who participated in this effort.

COMMENTS AND COMMITTEE REPORTS OF CITY COUNCIL:

Council Member Kirby indicated that in the memorandum on the Land Use Management Plan amendments, the ordinance for adopting the Plan is scheduled for Council consideration on September 13. Council Member Kirby requested that Council be given more time to review the material on the proposed amendments.

Council Member Silas commended the staff who participated in the Paint Tacoma Beautiful Project. Council Member Silas expressed her best wishes to Dick Moe (Chairman, Metropolitan Park District Board) for a speedy recovery from a possible heart attack.

Deputy Mayor Miller also expressed his concerns and best wishes to Dick Moe. Deputy Mayor Miller apologized to Mr. Skanes if he let his frustrations get in the way of their conversation on the boat launch.

Council Member De Forrest stated that the Tacoma firefighters who helped put out the fires in Western Washington did a good job.

He noted that one City employee from Sewer and two from Street Maintenance, who are members of the National Guard, were also called to assist with the fires in eastern Washington when the Governor declared a state of emergency. He indicated that the three employees who were called to assist with the fires had to have the time they spent putting out the fires deducted from their pay as "leave without pay." He stated that according to the Personnel Rules, 15 days are allowed for National Guard duties, but there is no provision for State-declared emergencies. Council Member De Forrest indicated that some of the colleagues of the three employees attempted to donate their sick and vacation time to assist the three individuals; but according to the Personnel Rules, this was not allowed. Council Member De Forrest said that he has talked with the Chair of the Civil Service Board to see if there could be a Rule change to accommodate these kind of circumstances. Council Member De Forrest also asked if there was anything that could be done to help these individuals.

Council Member McGavick reported that the Joint Commission on Domestic Violence, will be preparing a Comprehensive Plan on Domestic Violence and the Council will have an opportunity to review this Plan.

Council Member Baarsma reported on the pending crime bill currently before the United States Senate. He stated he discussed with Mr. Len Simon, the effects the House's action would have on the City's potential funding of \$2.7 million under this bill. Council Member Baarsma indicated that there is some funding available for domestic violence. Council Member Baarsma emphasized the need to upgrade the LESA's Computer Aided Dispatch system. He strongly urged that a message be sent to Senator Gorton pleading him not to be a part of a filibuster to kill the crime bill. He emphasized that the bill is critical to the City of Tacoma.

Council Member Evans announced that at next week's study session the Council will be discussing regional airports.

Council Member Silas congratulated Juli Daniel on her upcoming wedding.

Deputy Mayor Miller moved to cancel the September 6, 1994 Council meeting. Seconded by Council Member Crowley. Voice vote was taken and carried. The motion was declared adopted.

Deputy Mayor Miller moved that Council recess to Executive Session, not to exceed 30 minutes, to discuss pending and potential litigation. Seconded by Council Member Silas. Voice vote was taken and carried. The motion was declared adopted.

Council recessed to Executive Session at 7:40 p.m. and reconvened at 8:05 p.m.

On proper motion, the meeting was adjourned at 8:05 p.m.
