FINAL READING OF ORDINANCES

Ordinance No. 27251

Resolution No. 36296

Authorizing the execution of a consultant agreement with CES, Inc. Engineering, in the amount of \$1,155,582, to prepare plans and specifications for the replacement of a 600-foot segment of the Puyallup River Bridge located on Highway 99.

Deputy Mayor Evans moved to adopt Resolution No. 36296. Seconded by Council Member Phelps. Voice vote was taken and carried. The Resolution was declared adopted.

UNFINISHED BUSINESS

REPORTS BY CITY MANAGER

City Manager James L. Walton stated that the citizens of Tacoma will have a new way to access city government when the Community Relations Division unveils a new online newsroom site on the internet. He stated that the site is meant to be a "one-stop shop" for daily news on current city issues and will cover information on the 2005-2006 budget development. Mr. Walton stated that the site will provide links to current schedules, street construction project schedules, and other important city documents which are commonly requested by the public. He stated that the site fulfills one of the 2005 strategic plan goals to use technology to provide citizens with greater access to City news. Mr. Walton stated that there are no additional costs associated with the new site and that the site should be active by September 9, 2004.

Mayor Baarsma expressed his appreciation to Mr. Walton and Ms. Diane Supler, Office of Management, Budget, and Analysis Director for the budget presentation during the study session. He stated that the hard work staff has done to restrain spending and identify revenue for this year contributed to a balanced budget.

COMMENTS AND COMMITTEE REPORTS OF CITY COUNCIL

Council Member Lonergan congratulated the Tacoma-Pierce County Workforce Development Council (WDC) for its Recognition of Excellence-Honorable Mention award from the United States Department of Labor's Employment and Training



Administration. He stated that the award is connected to the WDC's work on the Pierce County Health Services Careers Council. He stated that Mr. Colin Conant and Ms. Linda Nguyen accepted the award, on behalf of the WDC.

Council Member Lonergan asked for a report on an issue in *The Pierce County Business Examiner* regarding accusations that the City of Tacoma is allowing the dumping of debris and fill dirt on city property without the proper permits. He stated that the allegations also included the Tacoma Public Utilities Department, Tacoma School District, and Metro Parks, all of which have been observed dumping debris at various government owned properties.

Council Member Lonergan stated that the Tacoma Fire Department is hosting a Remembrance Ceremony on Saturday, September 11, 2004, at the Firefighters Memorial on Ruston Way at 8:30 a.m., in honor of those who lost their lives in New York City, Washington, D.C., and Pennsylvania on September 11, 2001.

Mayor Baarsma congratulated Tacoma Chapter of the Sons of Norway on its 100^{th} Anniversary. He stated there are approximately 40,000 people of Norwegian descent who live in the Tacoma area, and there have been many Norwegian Mayors in the past.

Mayor Baarsma announced that the City Council study session, the weekly Council meeting and the Committee of the Whole meeting for Tuesday, September 7, 2004, have been cancelled. He stated that the next regularly scheduled meetings will be on September 14, 2004.

On proper motion, the meeting was adjourned at 6:05 p.m.
