Amending Chapter 13.06 of the Official Code to reclassify the property located on the south side of East 57th Street between McKinley Avenue and the Chehalis-Western Railroad right-of-way from an "R-2" One-Family Dwelling District to an "M-1" Light Industrial District to allow for the development of a mini-warehouse storage facility. (Tim Rooney; File No. 120.1225)

Mayor Sutherland moved to concur in the Findings, Conclusions and Recommendations of the Hearings Examiner. Seconded by Council Member Harnick. Voice vote was taken and carried. The motion was declared adopted.

Ordinance No. 23975

Amending Chapter 13.06 of the Official Code to reclassify the property located on the southwest corner of South 48th Street and Tacoma Mall Boulevard from an

"R-2-T" Residential-Commercial Transitional District to an "C-2" Commercial District to convert an existing 13,756 square foot office building into a retail "high-end" furniture store. (Trammell-Crow Company; File No. 120.1224)

Mayor Sutherland moved to concur in the Findings, Conclusions and Recommendations of the Hearings Examiner. Seconded by Council Member Harnick. Voice vote was taken and carried. The motion was declared adopted.

Final reading of the Ordinance was set over to a date to be determined.

Ordinance No. 23976

Amending the Pay and Compensation Plan to implement numerous job titles recommended by Ewing & Company effective January 1, 1988.

The Ordinance was set over for final reading next week.

Ordinance No. 23977

Accepting a donation of \$2,500.00 from the Ben B. Cheney Foundation; depositing said sum in the Miscellaneous Grants Summary Fund; transferring \$2,500.00 from the General Fund to the Miscellaneous Grants Summary Fund; and appropriating \$5,000.00 from the Miscellaneous Grants Summary Fund to provide funding for the Children's Design Exhibition at the Tacoma Dome to be held December 4-6, 1987.

The Ordinance was set over for final reading next week.

Ordinance No. 23978

Transferring the \$9,000.00 fund balance from the Medical Arts Construction Fund to the Municipal Building Acquisition and Operating Fund; and appropriating \$9,000.00 from the Municipal Building Acquisition and Operating Fund for the cost of improvements in the building piping system and other expenses relating to the Municipal Building.

The Ordinance was set over for final reading next week.

Resolution No. 29833

Authorizing the execution of an agreement with Kennedy/Jenks/Chilton, Inc. for engineering services relative to the renovation of the Cleveland Way Pump Station.

Council Member Mykland moved that the Resolution be adopted. Seconded by Council Member Nielsen. Voice vote was taken and carried. The Resolution was declared adopted.

Resolution No. 29834

Authorizing the release of a portion of a sewer easement for the property located near North 11th Street and Heatherwood Hest.

Council Member Mykland moved that the Resolution be adopted. Seconded by Council Member Moss. Voice vote was taken and carried. The Resolution was declared adopted.

REPORTS BY CITY MANAGER:

Erling O. Mork, City Manager, stated that staff had requested an Executive Session to discuss personnel matters.

COMMENTS AND COMMITTEE REPORTS OF CITY COUNCIL:

Council Member Hyde requested that staff send a letter to candidates to remind them to take down their election signs now that the election was over.

Mayor Sutherland stated that there was a letter to the editor of the Tacoma News Tribune expressing concerns regarding the flushing of hydrants on South Tacoma Hay. He requested staff look into the reasons for the depressurizing of the hydrants.

Mayor Sutherland noted that today, November 10, is the 212th birthday of the United States Marine Corps.

Mayor Sutherland moved to recess to Executive Session to discuss personnel matters, the session not to exceed 30 minutes. Seconded by Council Member Mykland. Voice vote was taken and carried. The motion was declared adopted.

Council recessed to Executive Session at 5:34 p.m.

Mayor Sutherland re-entered the Council Chambers at 6:02 p.m. and stated that the Executive Session would extend for an additional 15 minutes.
