## CITIZENS REQUEST TO BE HEARD:

Gaston Hooks, Jr. requesting to speak regarding the business license ordinance relating to Merchant Patrols.

Gaston Hooks, Jr. introduced his police dog Wolf and advised that he is in the business of training dogs and providing security for residents and merchants in the City of Tacoma. He said he had been in the business for a year and a half and has recently been approached by the Tax & License Department who advised that he was operating illegally without a license. Upon investigation he was informed that the City was set up in districts for security patrol which prohibited him from obtaining a license. He asked that the ordinance be changed by removing the requirement of districting and the limit on number of patrols throughout the City.

Council members had a number of questions which they asked the City Manager's office to prepare a response to and distribute to Council members, i.e. whether the Police Department makes periodic checks on licenses and whether they are renewable: a history on how other cities in the State handle this problem as it appeared that Tacoma was the only City in the State which operates under the Merchant Patrol district system; information on the liability as it would affect the City and on liability as to the use of canines and the trainers.

Mayor Parker advised that he would also send the correspondence that he has received in the past from the Police Department.

On proper motion, the meeting adjourned at 7:50 p.m.
