Earl Mittelstaedt, Finance Director, advised that the Council has before them a revised Ordinance. The estimates have been revised in the Ordinance submitted to them last week. There has been an increase in the anticipated levy of \$17,794 in the General Fund tax and \$2,542 in the Firemens Pension Fund.

Mr. Warnick moved to substitute and consider the revised Ordinance. Seconded by Mr. Nielsen. Voice vote was taken and carried.

Mrs. Bichsel moved to amend the motion as follows: \$5.00 for the first offense; \$20.00 for the second offense; \$35 for the third offense; and \$50.00 for the fourth and subsequent offenses. Seconded by Mr. Sonntag. Voice vote was taken on the motion and carried.

Mayor Johnston read a report of last year's offenses in the City of Tacoma submitted by Mr. Archie Fiddler. There were 4,030 first offenses, 939 second offenses, 222 third offenses and 132 fourth offenses.

# COMMENTS AND COMMITTEE REPORTS BY MEMBERS OF THE CITY COUNCIL:

Mr. Strege commented he attended the last meeting of the Citizens Budget Review Committee and they informed him they would be sitting in limbo until they received future direction from the City Council. He said he felt Council should resolve the question.

On inquiry of Mr. Sonntag, Mayor Johnston advised that new members are appointed to the Citizens Budget Review Committee annually. He asked that the City Manager submit an evaluation of the process to date and give his recommendations how the process could be more clearly understood by the citizens so that Council could receive information on how the community views the response of government to the needed services.

Mr. Warnick called attention to the fact the Human Relations Commission is in need of having its membership brought to strength and urged that appointments be made as soon as possible.

Mayor Johnston advised that the State Highway Commission met in Tacoma yesterday and the Tacoma area expressed the continued need for Route 509 and completion of SR 16. He also advised that Governor Evans will be at Tacoma Community College Wednesday, October 20, 1976 where he will present his proposed budget for the State for year 1977.
