Authorizing the expenditure of \$20,000 in 1991 and 1992 from the Uniform Controlled Substance Trust Fund in support of the Tahoma Narcotics Enforcement Team operations.

Amending Section 2.02.750 of the Official Code to allow the use of Earthquake Recording Instrumentation Program Funds for earthquake preparedness activities.
