REPORTS BY CITY MANAGER:

City Manager Ray E. Corpuz, Jr. announced that a full campaign on the curfew is under way. Cable 12 has been airing a public service announcement on the curfew featuring Mayor Moss. Also, 3000 responses were received to the curfew commitment card. KOMO-TV has featured a segment on this issue and THE NEWS TRIBUNE

wrote an article on this. On July 25, 1995, a drawing for family fun packs will take place at the City Council meeting. There are six billboards throughout the city promoting the curfew ordinance.

Mr. Corpuz indicated that staff is working on the issues raised on shoreline enforcement. He explained that staff will be taking steps to: 1) review all actions and issues raised in the article, 2) respond immediately to the issues, 3) meet with those individuals mentioned in the article and 4) examine the system for improvements and work with other public agencies.

Mr. Corpuz acknowledged the Community Connection efforts comprised of City employees who will be painting two homes in the Paint Tacoma Beautiful project.

COMMENTS AND COMMITTEE REPORTS OF CITY COUNCIL:

Mayor Moss announced that the City Council meeting of July 5, 1995 is canceled and that the next regular meeting of the City Council will be held on July 11, 1995. Mayor Moss indicated that the Council will be adjourning shortly to attend the City of Destiny Awards ceremony at the Theatre on the Square starting at 7:00 p.m.

Council Member De Forrest wished everyone a good Fourth of July holiday. Council Member De Forrest thanked Juli Wilkerson for the interesting E-mail information on the RTA survey.

Council Member Baarsma reported that he received a communication from Japan's National Land Agency the sponsor of the world lead off City conference in Hachinohe. Council Member Baarsma, who attended the conference as a City representative, indicated that the Land Agency is proceeding to organize an association of City participants of the Hachinohe conference. Tacoma has been invited to be a charter member of this association at no cost. The goal of the association is to establish links and communication that would foster trade and economic development. Council Member Baarsma said that he hoped the City of Tacoma would be participating in this association.

Deputy Mayor Evans indicated that he received a phone call from Hachinohe indicating that they will be visiting the area. He requested, as a matter of protocol, that the City of Tacoma recognize their attendance and participate in some of their activities. Deputy Mayor Evans indicated that a program that was aired on Dateline which had to do with people in trouble, featured a home from the North End. Deputy Mayor Evans, urged staff to continue to examine the serious problem of the conversion of single-family homes into multiple-housing units.

Council Member Miller announced the wedding of Mayor Moss on Saturday.

Council Member McGavick requested that the City Council be made aware of the Paint Tacoma Beautiful project. She indicated that she would like to volunteer on this project and help support City staff on this worthwhile project.
