# PUBLIC HEARINGS AND APPEALS: (Began at 5:58 p.m.)

This is the date set for hearing the appeal of Joan Lech regarding the decision of the Hearings Examiner to approve the request of the Atlantic Richfield Company for reclassification of the property located at the northeast corner of Orchard Street and South 56th Street. (File Nos. 120.1099 and 121.979)

Council Member Bichsel stated that she had received calls from two women regarding this issue. She indicated that she informed the women she could not discuss the issue prior to the appeal.

Council Member Kirby stated that he also had been contacted by individuals expressing concerns regarding both the City's reclassification and a similar Pierce County Reclassification. He stated that this would not affect his voting and that he would be unbiased on the issue.

Mr. James Thrasher, Hearings Examiner pro tem, made a presentation regarding the appeal.
