# FIRST READING OF ORDINANCES:

Ordinance No. 21150 (Continued from the meeting of August 16th)

Amending Chapter 13.06 of the Official Code to reclassify the area between North 29th Street and Schuster Parkway and approximately 150 feet east of Starr Street from an "R-2" to an "R-3" District. (Tricorp) (Appeals filed by Mr. & Mrs. Jas. Catalinich, Hazel W. Marek and Mildred J. Englund and 40 residents.)

Mr. Sonntag moved to refer the matter back to the Hearings Examiner who is to seek input from the North Slope Citizens' Advisory Committee and that the Ordinance be returned to Council for First Reading within 180 days. Seconded by Mr. Strege. Roll call vote was taken resulting in Ayes: 4 - Bichsel, Nielsen, Sonntag and Strege. Nays: 5 - Hudson, Nelson, Schroeder, Warnick and Mayor Johnston. The motion was declared failed.

Mr. Sonntag moved that the City Council reinstate condition No. 6 of the Hearings Examiners recommendations on his First Hearing on the Ordinance. The motion failed for lack of a second.

# Ordinance No. 21151

Amending Chapter 13.06 of the Official Code to reclassify the northeast corner of South 88th Street extended and Hosmer Street from an "R-2-T" to a "C-F-V" District. (David Sheean & Donald Schweber)

## PUBLIC HEARINGS AND APPEALS:

a. This is the date set for hearing the Appeal of Rovai, McGoffin, Turner & Mason, Attorneys at Law, for MBRM Investors, on the Hearings Examiner's decision to allow continued use of an off-street parking area in an "R-5-T" District and waiver of off-street parking area development standards to allow an existing parking area to remain unpaved at the southwesterly corner of South 8th and Yakima Avenue.

The appellants were not present at the meeting. Mr. Sonntag moved that the Appeal be continued for two weeks. Seconded by Mr. Strege. Roll call vote was taken resulting in Ayes: 5 - Hudson, Sonntag, Strege, Warnick and Mayor Johnston. Nays: 3 - Bichsel, Nielsen, and Schroeder. Absent: 1 - Nelson. The motion carried.

The Appeal was continued to September 6, 1977.

#### REPORTS BY CITY MANAGER:

Erling Mork, City Manager, reported that a change order on Phase I of the 16th and "K" Street Project is requested. Ron Button, Public Works Department Director, explained the change order would allow the existing contractor to do the rest rooms and the addition of the Arts Facility. Bids will be sought for the swimming pool.

Mayor Johnston moved to approve the change order. Seconded by Mr. Sonntag. Voice vote was taken and carried.

## COMMENTS AND COMMITTEE REPORTS BY MEMBERS OF THE CITY COUNCIL:

Mayor Johnston moved that the City of Tacoma, acting through the Tacoma-Pierce County Civic Arts Commission, be authorized to make application to the National Endowment for the Arts for a "Arts in City Neighborhoods" Program Grant, and further, that in the event that such grant application is approved, that the City Council declare its intent to provide the necessary cash matching funds equal to one-half of the program cost or \$35,000.00, to be included in the 1978 Budget as a Revenue Sharing project or from such other funding source as may be available. Seconded by Mr. Warnick. Voice vote was taken and carried.

Mr. Sonntag suggested concerts in the rotunds of the Bicentennial during the winter months.

Mr. Sonntag commented he will be sending to Council members a report on items which apply to Tacoma that were discussed at the National League of Cities Steering Committee for Employment and Income Support.

Mayor Johnston distributed to Council members the Knight, Vale and Gregory review of the Human Development Department and advised that Mr. Brown of Knight, Vale and Gregory will address the Council after Council has had an opportunity to review the report.

Mayor Johnston asked for a report on the future schedule of audit reports. Mr. Mork advised that the Resolution on the agreement and schedule is in the process of being finalized.

On proper motion the meeting adjourned at 7:10 p.m.
