Councilman Hyde moved to concur in the Findings, Conclusions and Recommendations of the Hearings Examiner. Seconded by Councilwoman Bichsel. Roll call vote was taken, resulting as follows: Ayes: 8 -Bichsel, Hawkins, Hyde, Nielsen, Rasmussen, Strege, Sutherland and Mayor Parker. Nays: O. Absent: 1 - Kirby.

Ordinance No. 22365

Authorizing a one-time payment to certain members of the Tacoma Employes' Retirement System whose retirement was effective prior to January 1, 1976.

Roll call vote was taken, resulting as follows:

Ayes: 5 - Bichsel, Hyde, Nielsen, Rasmussen and Mayor Parker.

Nays: 4 - Hawkins, Kirby, Strege and Sutherland.

The Ordinance was declared passed.

Mayor Parker moved to appoint Deputy Mayor Nielsen, Councilwoman Bichsel and Councilman Rasmussen to the determining authority for the North Shore Golf Associates Open Space Classification with the rest of the Council as alternates. Seconded by Deputy Mayor Nielsen. Voice vote was taken and carried.

Mayor Parker moved to approve a settlement of a law suit by Barbone Concrete Construction, Inc. in accordance with the recommendation of the City Attorney. Seconded by Councilman Sutherland. Voice vote was taken and carried with Deputy Mayor Nielsen abstaining.

Mayor Parker then announced they would hold the Public Hearing at this time. He then left the meeting at 6:06 p.m.

Ordinance No. 22366

Appropriating \$150,000.00, or so much thereof as may be necessary, from the Equipment Rental Capital Outlay Fund, Account "B", to purchase three items of equipment for maintaining the street lighting system by the Public Works Traffic Signal Division, and declaring an emergency making necessary the passage of this ordinance and its taking effect immediately upon publication.

Roll call vote was taken, resulting as follows:

Ayes: 5 - Bichsel, Hawkins, Rasmussen, Sutherland and Deputy Mayor Nielsen.

Nays: 2 - Kirby and Strege.

Absent: 2 - Hyde and Mayor Parker.

The Ordinance was declared failed since emergency ordinances require six yes votes.

Doug Brown, 1324 Browns Point Blvd., spoke on the ordinance.

The Ordinance was set over for final reading next week.

Ordinance No. 22367

Authorizing execution of an agreement with the Washington State Criminal Justice Training Commission to provide payment to the City for services rendered to provide basic law enforcement training for police officers throughout the State and appropriating \$22,775, or so much thereof as may be necessary, from the General Fund to provide materials, facilities improvement and instruction required to provide said training.

The Ordinance was set over for final reading next week.

Ordinance No. 22368

Amending Chapter 13.06 of the Official Code to reclassify the east side of Sprague Avenue at South 64th Street extended from an "R-2" to a "C-2" and "R-2-T" District. (C & I Company)

Councilwoman Bichsel moved to concur in the Findings, Conclusions and Recommendations of the Hearings Examiner. Seconded by Councilman Sutherland. Voice you was taken and carried.

The Ordinance was set over for final reading to a date to be determined.

Ordinance No. 22369

Amending Chapter 13.06 of the Official Code to reclassify the northerly side of Marine Yiew Drive between 62nd and 65th Avenues NE extended south from an "R-2" and "R-3" to an "M-2" District. (General Metals of Tacoma, Inc.)

Councilwoman Bichsel moved to concur in the Findings, Conclusions and Recommendations of the Hearings Examiner. Seconded by Councilman Sutherland. Voice vote was taken and carried.

The Ordinance was set over for final reading to a date to be determined.

Ordinance No. 22370

Amending Chapter 13.06 of the Official Code to reclassify the area in the vicinity of Marine View Drive and Slayden Road from former Pierce County classifications to an "R-1" District. (City of Tacoma)

Councilwoman Bichsel moved to concur in the Findings, Conclusions and Recommendations of the Hearings Examiner. Seconded by Councilman Sutherland. Voice vote was taken and carried.

The Ordinance was set over for final reading to a date to be determined.

Ordinance No. 22371

Amending the Pay & Compensation Plan to establish new classifications and amend certain existing classifications.

The Ordinance was set over for final reading next week.

Councilman Hawkins moved to continue the Resolution for one week. Seconded by Councilman Kirby. Voice vote was taken and carried. Resolution was continued until April 7, 1981.

Authorizing execution of a release agreement with the U.S. Naval Reserve and purchasing of required insurance to allow Naval Reserve personnel to provide free labor for improvements at Alderwood Park.

Councilman Rasmussen moved that the Resolution be adopted. Seconded by Councilwoman Bichsel. Voice vote was taken and carried. The Resolution was declared adopted.

Resolution No. 26895

Authorizing the Purchasing Agent of the City to make purchases of petroleum using informal procedures on a need basis.

Councilman Sutherland moved that the Resolution be adopted. Seconded by Councilwoman Bichsel. Voice vote was taken and carried. The Resolution was declared adopted.

The Public Hearing was held earlier in the evening.

REPORTS BY CITY MANAGER:

Erling Mork, City Manager, asked the Council if they wish to discuss the revised schedule for selection of the firm to construct the Sports/Convention Center.

After discussion, Councilman Sutherland moved to retain the original schedule which would make April 21st the date the Council selects the firm. Seconded by Councilwoman Bichsel. Voice vote was taken and carried.

Mr. Mork then introduced Fran Chapin, Chief Assistant City Attorney, who requested a residency waiver for their new Assistant City Attorney, Christine P. Nicksic. He stated she plans to relocate in the City as soon as she is able to.

Deputy Mayor Nielsen moved to grant a residency waiver for nine months. Seconded by Councilman Sutherland. Voice vote was taken and carried with Councilman Street voting No.

Mr. Mork advised the Council that State Representative Art Wang was detained in Olympia and was not able to attend the public hearing on WPPSS. He has just arrived and would like to speak to the Council.

Councilman Kirby moved to suspend the rules to allow State Representative Art Wang to testify on the Public Hearing matter. Seconded by Councilman Strege. Voice vote was taken and carried.

State Representative Art Wang, 2402 North Madison, spoke on the Supplemental Agreement for WPPSS.

COMMENTS AND COMMITTEE REPORTS BY MEMBERS OF THE CITY COUNCIL:

Councilman Kirby stated he received a communication advising that action would be taken in the very near future against the illegal float and dry dock on Ruston Way. He asked that the Council be advised exactly when this would take place.

Councilman Kirby also requested a detailed report from the Metropolitan Park District regarding the Wapato Lake cleaning project.

Councilman Hawkins stated that House Bill 261 moved out of Committee and into Rules. If there is an effort to get this to the Senate, he would like to know what contingencies the City and the Association of Washington Cities have taken to avoid that.

Councilman Sutherland advised the Council that the Association of Washington Cities will have their annual meeting June 16-19, 1981. They have requested the Council appoint a member to the Nominations

Committee and one to the Resolutions Committee. He stated he will serve on one Committee and requested someone else volunteer to serve on the other Committee.

Councilman Sutherland stated the Civic Arts Commission requested a Council member be appointed to work with them on the art work for the 12th Floor and he volunteered to do this.

On proper motion, the meeting adjourned at 8:52 p.m.
