Ordinance No. 27079

Amending Chapter 13.06 of the Municipal Code to implement the Industrial Zoning Code Update; to combine numerous industrial uses into two broad categories to clarify sign, landscaping and other development requirements in industrial districts; to restrict certain non-industrial uses in the industrial districts; to re-designate "M-3" Heavy Industrial District to "PMI" Port Maritime & Industrial District, to maintain consistency within the Zoning Code and to complete a rezoning from "R-2-T" Residential Commercial Transitional District to "T" Transitional District.

Deputy Mayor Moss moved as a substitute, Substitute Resolution No. 27079. Seconded by Council Member McGavick. Voice vote was taken and carried. The motion was declared adopted.
