City Council Chambers September 13, 1977

The meeting was called to order at 5:03 p.m.

FIRST READING OF ORDINANCES:

COMMENTS AND COMMITTEE REPORTS BY MEMBERS OF THE CITY COUNCIL:

Mayor Johnston advised that a communication had been received by the City Clerk's office requesting that the date set for the hearing on the appeal of Ken W. Johnson, which was set by Council last week, be rescheduled from Thursday, September 22, 1977 to October 25, 1977.

Mr. Nielsen moved that the hearing on the appeal be rescheduled to October 25, 1977. Seconded by Mrs. Bichsel. Voice vote was taken and carried.

Mayor Johnston referred to two study sessions on the processes of the Comprehensive Employment Service Council on the ex-offender program. He advised he would not be able to attend a meeting on the program on Thursday. He read a statement he was recommending be sent to the Comprehensive Employment Services Council stating the Council's position.

Council members approved the City's position as recommended.

Mr. Sonntag referred to the Washington State Legislative Committee Meeting held last week end. He advised that many of the bills discussed were ones the City had been concerned with. He urged that the City become involved with the bills prior to the committee hearings.

Mr. Sonntag expressed the appreciation of the citizens of Tacoma to the protection afforded them by the members of the Fire and Police services.

Mr. Sonntag moved to continue Item 15 of the agenda, Arnold J. Herrmann's request to speak, for two weeks. Seconded by Mrs. Bichsel. Voice vote was taken and carried. The item was continued to September 27, 1977.
