The meeting was called to order at 5:11 p.m.

## CONSENT AGENDA

Approval of the minutes of the City Council meetings and study sessions of January 7 and 14, 2003.

Council Member McGavick moved that the Consent Agenda be approved. Seconded by Council Member Miller. Voice vote was taken and carried. The Consent Agenda was declared approved.

Mayor Baarsma, with the indulgence of the Council, moved to hear "Reports by the City Manager" at this time.

## **REPORTS BY CITY MANAGER**

Acting City Manager James L. Walton stated that the City Council had directed staff to revisit the issue of some of the City's series streetlights that had been turned off in response to budget cuts. Mr. Walton then called on Mr. Bill Pugh, Director of Public Works, for an update.

Mr. Pugh updated the City Council on short and long term options regarding the series streetlight issue along with a citizen communication plan. Mr. Pugh reviewed the locations of the circuits that have been turned off. He reviewed the safety conditions of some of the circuits. Mr. Pugh discussed interim lighting and using the Local Improvement District process for long-term repairs of the circuits. He stated that there are 34 remaining circuits that are still on, but are in very poor condition. Mr. Pugh proposed shutting those circuits off in four years and monitoring them during that time. Mr. Pugh stated that if, during that time, the 34 remaining circuits become a safety hazard, interim lighting may be used for the short-term and possibly using the Local Improvement District process for the long-term solution. He stated that notification will be sent to the property owners and that two focus meetings with citizens in the area will be held in the near future. Mr. Pugh concluded that some of the locations where the series streetlight circuits are located are within Community Development Block Grant eligible areas and funding may be available through the Grant.
