Awarding contracts to:

Mack, in the amount of \$70,000, plus 10 percent for expenses, budgeted equally from the Surface Water Fund and by the Department of Public Utilities, for legislative liaison and other related activities during the 2006 session of the Washington State Legislature and continuing through December 31, 2006.

Resolution No. 36720

Authorizing the execution of an amendment to the agreement with Simon and Company, in the amount of \$35,000, plus \$2,500 for expenses, budgeted from the Surface Water Fund, for congressional liaison and related activities during the 2006 session of the United States Congress and continuing through December 31, 2006.

Resolution No. 36723

Amending Chapter 1.12 of the Municipal Code to implement rates of pay and compensation for employees in unrepresented executive classifications; amending the executive salary plan for classifications related to ten positions at Tacoma Public Utilities; adding the classifications of Deputy Utilities Director and Deputy Power Division Superintendent to said plan; and amending the salary range for Assistant City Manager.
