## Ordinance No. 22020

Authorizing acceptance of a grant for \$45,000 from the State of Washington through Pierce County; accepting \$22,500 from Pierce County; appropriating \$67,500, or so much thereof as may be necessary, to continue the County and City Historic Properties Survey; and declaring an emergency making necessary the passage of this ordinance and its taking effect immediately upon publication.

## Ordinance No. 22021

Appropriating \$18,176.45, or so much thereof as may be necessary, from the Cumulative Reserve for Replacement of Fire Equipment Fund and the General Fund to pay the cost of acquiring new Fire Dept. vehicles; authorizing purchase of said vehicles under State contract; and declaring an emergency making necessary the passage of this ordinance and its taking effect immediately upon publication.

## Ordinance No. 22022

Vacating North Ferdinant from North 16th south 120 feet. (Nancy P. Lewis and Frederick L. Wilson)

## Ordinance No. 22023

A citizen requested permission to speak against the ordinance. She was informed that City Ordinance requires that public testimony on rezones be made at the Hearings Examiner's public hearing; however, if the Findings, Conclusions and Recommendations of the Hearings Examiner are appealed then the City Council holds the hearing at which time the public is permitted to speak on the issue. The lady advised that she came to the Council meeting to appeal. It was then determined by the City Council, after reviewing the documents before them, that the last day to appeal was March 25th and the present day is March 25th. She was informed that the appeal is to be made in writing and filed with the City Clerk today. This she said she would do.

# COMMENTS AND COMMITTEE REPORTS BY MEMBERS OF THE CITY COUNCIL:

Councilmembers Bichsel and Hawkins reported on their recent trip to Washington, D.C. where they attended a meeting of the National League of Cities. They met with Senators Magnusson and Jackson and Congressman Dicks. They learned that an important energy block grant legislation will be introduced and that Senators Magnusson and Jackson will be added to the group of sponsors. Subjects also discussed were the SPUR, Pantages Theater and shoreline jurisdiction and the impact of the anticipated Federal Budget cuts on CSTA and Revenue Sharing.

Councilman Rasmussen asked for the continued involvement of the Citizens' Advisory Committee on the Mini-Dome.

Councilman Strege commented on a recent meeting of the Joint Municipal Action Committee in which the school district proposed an agreement of mutual cooperation with the City regarding growth in the Northeast Tacoma area, which has placed a great burden on the schools. They would like to form a City/School District Committee to investigate alternatives to placing restrictions on growth in Northeast Tacoma and to then present recommendations to the City and the School District.

Councilman Sutherland requested that matters from the Hearings Examiner not be on the agenda until after the last day to appeal has expired.

Deputy Mayor Nielsen moved to recess into Executive Session to discuss a matter of litigation. Seconded by Councilman Rasmussen. Voice vote was taken and carried. Council recessed at 6:45 p.m. Council reconvened at 6:58 p.m.

Councilman Rasmussen moved that the claims of Gary Atkinson, Irene Cairns, Edward Ehmke and Ray H. Sayger be settled in accordance with the recommendations of the City Attorney. Seconded by Councilman Sutherland. Voice vote was taken and carried.
