Council Member Moss stated that KIRO announced that they will be issuing video bulletins on the election tonight.

Council Member Evans announced that the musical event at the Municipal Dock on September 11 was interesting.

Mayor Vialle announced that the Tacoma Art Museum has a very good traveling exhibit of the history of the U.S. and Mexico.



Council Member Baarsma reported that three neighborhood council meetings have been held so far and there had been approximately 100 people in attendance at each meeting. He indicated there has been a good interest in the number of people wanting to serve on the organizing committee for each neighborhood council.

Council Member Baarsma announced that on September 15, the West End Neighborhood Council will meet. The Central Neighborhood Council and the Central Business District will both meet on September 16. The Northeast Neighborhood Council will meet on September 20 and the South Tacoma Neighborhood Council will meet on September 23.

Council Member Silas announced that at 8:00 a.m. on September 15, 1993, the K Street Post Office will be dedicated as the "Martin Luther King Post Office."
