#### FIRST READING OF ORDINANCES:

Ordinance No. 20886 Amending Chapter 13.06 of the Official Code to reclassify the northwest corner of South 19th and Mildred Streets from an "R-P" and "R-3-PRD" to a "C-P-C" District. (Huber & Antilla Construction C

Hearings Examiner, Robert Backstein, gave a detailed explanation of the reclassification and responded to questions by members of the Council.

Speaking in support of the ordinance were Mr. Huber, one of the petitioners, and his attorney, Mr. John Petrich.

Following a lengthy discussion, the Ordinance was set over for final reading to a date to be determined.

Ordinance No. 20887 Ordinance No. 20887 Creating a new fund to be known as the "Data Management System Grant Fund; accepting a grant award for \$10,534.00 from the Puget Sound Council of Governments; authorizing certain appropriations for the purpose of developing the preliminary design of a Data Management and Operation System for the Elderly and Handicapped Transportation Program and declaring an emergency making necessary the passage of this ordinance and its taking effect immediately upon publication.

Mel Jackson, Director of the Department of Human Development, proposed an amendment to the Council incorporating the following changes: On page one, the figure of \$10,534 on line five, should be changed to \$7,072; One line eight, the figure of \$14,287 should be changed to \$10,825; and on line ten, the figure \$10,534 should be changed to \$10,825. One page two, on line sixteen, the figure \$10,534 should be changed to \$7,072. On page three, line three, should read, \$10,825. On line 25, the figure should read \$10,825.

City Manager Mork told the Council that he is continuing to have some difficulties working out the details of the proposed agreement and recommended the Resolution be removed from the Agenda.

Resolution <u>No. 24103</u> Authorizing the execution of an agreement with the Puget Sound Council of Governments for an Urban Mass Transportation Administration Transportation Systems Management Program technical study project.

Mr. Nelson moved to adopt Substitute Resolution 24103. Seconded by Mr. Sonntag. Voice vote was taken and carried. The Substitute Resolution was adopted.

Resolution No. 24104 Authorizing an amendment to the agreement between the City and the Tacoma Public Library for additional costs for restoration of the Carnegie Building.

Mr. Hudson moved that the Resolution be adopted. Seconded by Mr. Nelson. Voice vote was taken and carried. The Resolution was declared adopted.

Resolution No. 24105 Authorizing an agreement with the Federal Aviation Administration to provide maintenance of the fixed beam ceiling light at Tacoma Industrial Airport.

Mr. Hudson moved that the Resolution be adopted. Seconded by Mr. Strege. Voice vote was taken and carried. The Resolution was declared adopted.

Resolution No. 24106 Authorizing execution of a Permit Agreement for Temporary Sewer Service with Oscar T. Hokold in the vicinity of South 92nd and Hosmer Streets.

Mayor Johnston then made a motion to suspend the rules for the purpose of hearing a proposal by the Reverend Winckley. Seconded by Mr. Schroeder. Voice vote was taken and carried.

Reverend Winckley made a lengthy request before the Council, asking the City to sign an application to the State for funds under Referendum 29 for the acquisition of a day care center in the Hilltop area. He stated the estimated cost would be approximately \$300,000 for the 50 bed facility. He stated the application would require the City to put up 75 percent of the cost and that the additional 25 percent cost would be raised by himself in other areas.

No action was taken by the Council.

Mayor Johnston then made a motion to recess into Executive Session for the purpose of hearing a brief review on the City's current labor negotiations. Seconded by Mr. Nielsen. Voice vote was taken and carried. The Council recessed at 7:20 p.m.

Mayor Johnston reconvened the regular meeting at 9:44 p.m. Mr. Schroeder moved that the meeting be adjourned. Seconded by Mr. Nelson. Voice vote was taken end carried. The meeting was adjourned.
