PUBLIC HEARINGS:

- a. This is the date set for public hearing on proposed use of revenue sharing funds for the 1979 fiscal year.

Pete Luttrupp, Assistant Finance Director, advised that the revenue sharing laws require public hearings on proposed use. This is the first hearing which is on the funds going to the General Government use. Next week the hearing on Tuesday, the 26th, will be held on the use of a portion of the funds for community based projects. Later, during the budget review process, there will be an actual use hearing.

Darrell Matz, Budget Division of the Finance Department, reviewed for Council the various categories and amounts of the proposed use of the \$3,886,946 of revenue sharing funds for 1979.

Members of the public speaking were:

No other citizens appeared to be heard at the hearing.

The Mayor declared the hearing closed.

- b. Informal hearing on L.I.D. for permanent paving on South Ainsworth Avenue from South Wright Avenue to South 35th Street, South Sawyer Street from South Wright Avenue to South 35th Street, and South Wright Avenue from South Sawyer Street to South Chandler.

Councilman Evans, Chairman of the L.I.D. Committee, advised the L.I.D. had been approved by a small margin by the people in the area. A great deal of time transpired between the time they approved it and the bid was received from the contractor. The contract is 50% higher than what the people had expected. Since the fact that the vote had been so close, the L.I.D. Committee felt these people should have the opportunity to present their case to the City Council.

Ron Button, Director of Public Works, advised that the L.I.D. was formed on August 22, 1977. The original estimate was \$33.75 per lineal foot. The cost is now \$50.50 per lineal foot. The original protest was 44%, it is now 47%.

No other citizens came forward to speak.

Mayor Parker declared the hearings closed and announced that the subject would be before Council next week for decision.

COMMENTS AND COMMITTEE REPORTS BY MEMBERS OF THE CITY COUNCIL:

Councilman Strege commented on past gardner projects and moved that the City Council recommend to the Department of Community Development that an interim neighborhood strategy area be designated for those eligible areas in the fourth year Community Development Project entitled "The Urban Garden Project." Seconded by Councilman Nielsen. Voice vote was taken and carried.

Councilman Warnick commented on the Tacoma Industrial Airport and said it has been brought to his attention by Mr. Ketler who has leased property at the airport for hangar storage, that his request for expansion was denied by the Fire Marshall because of inadequate water supply. Also, Dr. Billingsley, a fixed based operator at the airport, has been denied a similar request. Councilman Warnick suggested a meeting with the interested parties to see what can be done to rectify this situation. Acting City Manager, Severo Esquivel, said he would investigate and submit a report and recommendation to City Council.

Deputy Mayor Warnick reported that he has received complaints that people are speeding along Yakima Avenue between Division and McCarver Street, along that one mile stretch, without any impediment. He requested that the Traffic Division make a determination on a method of instituting deterrence along the street. He asked that a report be provided to Council outlining improvement of the situation.

Mayor Parker reported that the Princess Marguerite will be sailing from Tacoma on Wednesday, October 11th. The trip is to be co-sponsored by KTNT Radio Station and the Tacoma Athletic Commission. Ticket cost is \$20 for adults and \$12 for children, 6-11 years of age; children under six are free.

Mayor Parker appointed the L.I.D. Committee members for the months of October, November and December. Members appointed are Councilwoman Bichsel, Councilman Hudson and Councilman Evans.

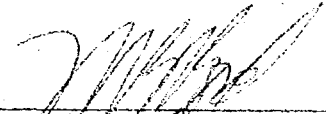
