CITY COUNCIL MINUTES

City Council Chambers September 19, 1995

The meeting was called to order at 5:25 p.m.

Present on roll call: 6 - Baarsma, De Forrest, Kirby, Miller, Silas, and Deputy Mayor Evans. Absent: 3 - Crowley, McGavick, and Mayor Moss. (Council Member McGavick arrived at 6:30 p.m.)

The Flag Salute was led by Council Member Silas.

Council Member Miller moved to excuse the absences of Mayor Moss and Council Members Crowley, De Forrest and McGavick from the Special Meeting of the City Council that was held at 4:00 p.m. today. Seconded by Council Member Baarsma. Voice vote was taken and carried. The motion was declared adopted.

Deputy Mayor Evans called of Mr. Dave Fruitger, of the Public Works Department, who presented the Council with an award for Tacoma's recycling program.

Ordinance No. 25763

Amending Chapter 1.06 of the Municipal Code to authorize the City Manager and Director of Utilities to allow their assistants, department directors or superintendents to approve professional and/or personal service contracts for amounts up to \$15,000.

The Ordinance was set over for final reading next week.

Ordinance No. 25764

Amending Chapter 12.06 of the Municipal Code relative to waiving the Cost Adjustment Clause on the Bonneville Power Administration's 1995 power and transmission rate increases.

The Ordinance was set over for final reading next week.

Council Member Miller moved to continue Resolution No. 33151 to the meeting of October 3, 1995. Seconded Council Member Baarsma. Voice vote was taken and carried. The motion was declared adopted.

Resolution No. 33152

Authorizing the execution of Amendment No. 114 to the Neighborhood Preservation Program agreement with the Tacoma Community Redevelopment Authority in the amount of \$155,000 to make payments on the Section 108 Demonstration Program Note.

Council Member Miller moved to suspend the rules to consider Substitute Resolution No. 33152. Seconded by Deputy Mayor Evans. Voice vote was taken and carried. The motion was declared adopted.

Council Member Miller moved that the Substitute Resolution be adopted. Seconded by Council Member Silas. Voice vote was taken and carried. The Substitute Resolution was declared adopted.

UNFINISHED BUSINESS:

None.

REPORTS BY CITY MANAGER:

Acting City Manager James Walton announced that TV Tacoma Channel 12, will replace its regular scheduled programming to cablecast the Pierce County election returns beginning at 9:00 p.m. The station will switch back to its regular programming at 6:00 a.m. on Wednesday, September 20, 1995. The returns for the Mayoral and City Council race will be displayed every 5-10 minutes on the screen starting at 9:00 p.m.

COMMENTS AND COMMITTEE REPORTS OF CITY COUNCIL:

Council Member Miller moved to excuse Mayor Moss and Council Members McGavick and Crowley from tonight's Council meeting. Seconded by Council Member Baarsma. Voice vote was taken and carried. The motion was declared adopted.

Council Member Miller encouraged voters to fill-out their ballots. Voters can still get their ballots out to the Evergreen Post Office until 10:00 p.m. to have them postmarked with today's date. Council Member Miller reported on The News Tribune's article on Tacoma's business climate and being rated number one in Entrepreneurial Magazine. He noted that this was a follow-up to the news reported on Intel. He encouraged the City's economic development staff in conjunction with the Economic Development Board to make use of these two announcements to move forward to promote Tacoma and take advantage of this moment.

Council Member Miller reported that he received numerous complaints in the Commerce and Jefferson area. It is a high area for debris, litter, needles and drug trafficking. He requested that the Police Department take some enforcement action in this area.

Council Member Miller asked for information on local preference contracting, specifically, what ordinances the City of Seattle and King County have in place in regard to local preference for contracting in the fields of consultants, engineers, architects, and attorneys. He also asked for information on all City consultant contracts and their principal place of residence within the last two-three years. Council Member Miller reported that he was recently presented with the State-wide award for community service from the Washington State Realtors. He thanked his colleagues for their support in helping him to receive this award.

Deputy Mayor Evans announced that next week's Council meeting will be held at the Tacoma Dome, 2727 East D Street beginning at 5:00 p.m., followed by the Summer Reading Library Awards.

Deputy Mayor Evans indicated he also received calls about the Jefferson and Commerce area. He reported that there are needles and broken glass in the landscaping area. Deputy Mayor Evans reported on the counselor reception he attended on behalf of the Mayor at the Historical Museum. He then reported on the phone calls that he received concerning noise being generated from students and their parties. He indicated that the institution where these students are residents or participants have been contacted to correct this situation. Deputy Mayor Evans reported that the fixtures for lighting of the 11th Street bridge are being erected. He thanked all of the individuals who have been working on putting this project together.

Council Member Baarsma echoed the comments of Council Member Miller and Deputy Mayor Evans about the condition of the streets at Jefferson and Commerce. Council Member Baarsma indicated that it has been brought to his attention that there are signs stapled or nailed into utility poles that are distracting in appearance and may create problems for City employees working on the poles. He requested the Deputy City Manager to provide him with the statutes and ordinances that address this issue. He indicated that some of the posted signs have individual names and phones numbers

listed on them. He asked staff to provide information on what other communities are doing on enforcement and look at ways the City can take care of this.

Council Member McGavick arrived at 6:30 p.m.

Council Member Miller noted that a constituent informed him that the City's sewer division seems to have no problem with putting a free wood sign without a permit along Ruston Way while others are chastised. He indicated that the posting of signs on telephone poles is not dissimilar to his own frustrations about politicians who make use of the City's rights-of-way for the placement of their signs despite the fact that there is a law in place that allows the City to collect those signs and charge back the cost of collection to the politicians.

Council Member Kirby also commented about the problems at Jefferson and Commerce. Council Member Kirby commented that the flowers on the dais tonight were from his wife to remind him of their 20th wedding anniversary tomorrow.

Council Member McGavick apologized for not coming to the Council meeting on time. She explained that today was the first day faculty was back at Green River.

Council Member Silas also expressed concern about the problems at Jefferson and Commerce Streets.

Council Member De Forrest congratulated Council Member Miller for receiving the State-wide award. He wished Council Member Kirby a happy anniversary. He thanked Deputy Mayor Evans for organizing the 11th Street Bridge lighting project.

Council Member De Forrest moved that the City Council of Tacoma instruct our legal counsel to intervene in the scheduled superior court hearing, Tacoma Public Library vs. Carolyn Woesner, et al., on Friday, September 22, 1995. It is the desire of the City Council that our current public records policy be protected. Seconded by Council Member Kirby.

Council Member De Forrest indicated that the purpose of the motion is to bring to the Council's attention that there is a dispute about public records. He explained that in conversations with the City Attorney, it was recommended that the Council discuss the legal merits in Executive Session.

Council Member De Forrest moved to recess to Executive Session not to exceed 15 minutes. Seconded by Council Member Baarsma. Voice vote was taken and carried. The motion was declared adopted. The Council recessed to Executive Session at 6:45 p.m. At 7:05 p.m., Deputy Mayor Evans announced that Executive Session would be extended an additional 15 minutes. The Council reconvened at 7:22 p.m.

Council Members De Forrest and Kirby withdrew their motion.

Council Member Miller moved to suspend the rules to consider a motion related to Library Board law suit action. Seconded by Council Member Baarsma. Voice vote was taken and carried. The motion was declared adopted.

Deputy Mayor Evans moved that the Council state that the suit to declare the employee records non-discloseable was brought as an independent decision of the Library Board without City Council consultation or approval. Seconded by Council Member Baarsma. Voice vote was taken and carried. The motion was declared adopted.

On proper motion, the meeting was adjourned at 7:25 p.m.
