Creating a new fund to be known as the Title I Employment & Training Fund - 1978; accepting a grant in the amount of \$1,391,331 from the U.S. Dept. of Labor and appropriating said funds to provide employment and training services to unemployed and underemployed City residents and declaring an emergency making necessary the passage of this ordinance and its taking effect immediately upon publication.

Awarding contracts to: International Harvester Co. on its bids of \$309,813.78 for refuse packer cabs and chassis; to Perfection—Cobey Co. on its bid of \$221,246.33 for refuse packer bodies and to Special Trucks, Inc., on its bid of \$180,532.50 for refuse packer assemblies and to Carl T. Madsen, Inc., on its bid of \$40,175 for Imp. 8113.

Mr. Button, Director of Public Works, advised that they have again reviewed the bids on the side loading refuse trucks and recommend these bids be rejected at this time as they would like to work on the specifications a little longer and place them out for bids again as there is the possibility some money can be saved.

Resolution No. 24608

Authorizing application to the U.S. Dept. of Labor for a grant in the sum of \$1,391,331.00 for comprehensive employment and training services for eligible City residents.

Aaron B. Lee representing the Corrections Mental Health Unit of the Comprehensive Mental Health Center Tacoma-Pierce County, requested that Council include additional funds for their requested program which had been reduced by the Advisory Council.

Motion to adopt was made at the September 6, 1977 meeting. Voice vote was taken and carried. The Resolution was declared adopted.

Resolution No. 24630

Authorizing execution of an agreement with Dames and Moore, Consulting Engineers to provide certain services in implementing the Coastal Zone Management Project.

Authorizing execution of an agreement with Baseball Tacoma, Inc., for the use of Cheney Stadium and the Disabled American Veterans Harmony Chapter No. 18, for continued operation of the parking concession.

APPEALS:

This is the date set for hearing the appeal of Rovai, McGoffin, Turner & Mason, Attorneys at Law, for MBRM Investors, on the Hearings Examiner's decision to allow continued use of an off-street parking area in an "R-5-T" District and waiver of off-street parking area development standards to allow an existing parking area to remain unpaved at the southwesterly corner of South 8th and Yakima Avenue. Bob Backstein, Hearings Examiner, reviewed the request for the Special Use Permit and waiver of the off-street parking development standards and his recommendation.

Keith McGoffin, representing MBRM Investors, pointed out to the Council the inconsistency of requiring that his parking lot be paved while the School District parking lot across the street goes unpaved.

After discussion Mr. Sonntag moved to overrule the Hearings Examiner and grant the appeal and to include landscaping and that the matter be reconsidered by Hearings Examiner and Council in three years. Seconded by Mr. Strege. Voice vote was taken and carried.

REPORTS BY CITY MANAGER:

Erling Mork, City Manager, reminded Council of the joint Study Session with the Public Utilities Board on Monday evening at the Public Utilities Building.

COMMENTS AND COMMITTEE REPORTS BY MEMBERS OF THE CITY COUNCIL:

Mr. Hudson reported on the all day meeting he attended this day as a member of the COG of the Puget Sound Council of Governments. He reported that they delayed the removal of the coastal zone area, that portion of land in all the Puget Sound area and land east of Port Angeles. He said the State will be moved out of the position where they have had a policy of oil port facilities and as a result there will be no policy. He reported the position of the Executive Board was to take no action at this time until the people in the Puget Sound area assessed the disposition. He indicated there are several openings on an Ad Hoc Committee and hoped a member would be from the City Council. He also advised that a hearing would be held on the subject on October 5, 1977.

Mr. Schroeder referred to the enactment of the electrical surcharge several months ago and said he was proud that the Council had the courage to do what was necessary and is now encouraged to learn it will soon be removed.

He also referred to the recent primary election in which he lost in the nomination for Mayor and advised he would serve out his term as Councilman.

Mr. Strege reported that the Growth Policy Association, Housing Policy Group, of which he is a member, has been encouraged to continue their efforts in Urban housing. The Board has recommended, however, some changes in Pierce County and he will be forwarding this information to Council and the City Manager for review and comments.
