Amending Section 5.20 of the Official Code to establish new Refuse Utility collection and disposal service rates to be effective January 1, 1990.

Mayor Sutherland announced that this was the second public hearing on the refuse rates and stated that testimony would be taken during final reading of this ordinance.

Mayor Sutherland called for testimony.

There being no testimony, the public hearing was closed at 5:21 p.m.

The Ordinance was declared passed.

Ordinance No. 24511

Adopting the Annual Budget of the City of Tacoma for the fiscal year 1990.

Mayor Sutherland moved to suspend the rules to consider Substitute Ordinance No. 24511. Seconded by Council Member Warnick. Voice vote was taken and carried. The motion was declared adopted.

Mayor Sutherland stated that the Council had agreed that public testimony would be allowed on the motions to amend the ordinance at tonight's meeting.

Council Member Stenger moved that the following changes be made to the 1990 Substitute Budget Ordinance No. 24511.

- Of the \$650,000, 1/4% Real Estate Excise Tax, and the \$1,610,000 in General Fund dollars set aside for the Capital Improvement Program, \$1,250,000 will be appropriated for the State Historical Museum land purchase next to Union Station and \$150,000 will be appropriated for the continuation of the Ornamental Streetlighting Program. No other dollars will be funded to the Capital Improvement Program in 1990. Therefore, of the \$1,610,000 only \$750,000 shall be transferred to the Capital Improvement Program Fund.
- \$25,000 to the Arts Commission for the Arts Stabilization Program to provide financial and operational support to major arts organizations in conjunction with dollars received from the State and private sector.
- \$25,000 to the Arts Commission for a continuation of the Arts Support Program funded in 1989 to complement the 1990 Goodwill Games.
- \$25,000 to the Pantages Theatre to establish a fund needed to repair and replace capital items.
- \$100,000 to the Contingency Fund for a total funding level in 1990 of \$200,000.
- \$158,000 additional funding for the Tacoma Public Library.
- \$35,000 to the Human Development Department to provide full year funding for the Martin Luther King programs added mid-year 1989 and funded for only half a year in the preliminary budget.

- \$700,000 additional funding for the Metropolitan Parks District. It is understood that this is one-time funding only, and that the District will seek voter approval in early 1990 for a five-year maintenance and operation levy.
- \$131,000 to fund five additional police officers for six months.
 Full year funding will be provided 1991.

The total cost of this amendment is \$2,599,000. Seconded by Council Member Mykland.

Voice vote was taken and carried, with Council Member McElliott voting nay. The motion was declared adopted.

Council Member Warnick moved that the following addition be made to the 1990 Substitute Budget Ordinance No. 24511:

The addition of \$15,000 to the Arts Commission Grant Match Program currently funded at \$25,000. The Grant Match Program matches dollar for dollar contributions from the private sector. An additional \$15,000 would actually provide \$30,000 for increased funding to such organizations as the Tacoma Youth Symphony, Balletacoma, Tacoma Art Museum, etc.

Seconded by Deputy Mayor Hyde.

Roll call vote was taken as follows:

Ayes: 6 - Hyde, Moss, Nielsen, Stenger, Warnick, and Mayor Sutherland.

Nays: 3 - McElliott, Mykland, and Vialle.

The motion was declared adopted.

Deputy Mayor Hyde moved that the following addition be made to the 1990 Substitute Budget Ordinance No. 24511:

 \$50,977 in additional funding for the Public Works Department for two staff persons needed to provide staff support to the Environmental Commission.

> Clerk Typist II \$25,240 Environmental Specialist \$44,090 Total \$69,330

In the preliminary budget, \$18,353 had been set aside for temporary clerical assistance in the Public Works Department, Buildings Division; these temporary dollars are to be eliminated. The net effect to the budget is \$50,977. In 1989, these two staff positions were supported through temporary dollars from the General Fund and dollars from the Sewer Utility Division.

Seconded by Council Member Mykland.

Roll call vote was taken, resulting as follows:

Ayes: 7 - Hyde, Moss, Mykland, Nielsen, Stenger, Vialle, and Warnick.

Nays: 2 - McElliott and Mayor Sutherland.

The motion was declared adopted.

Council Member Mykland moved that the following addition be made to the 1990 Substitute Budget Ordinance No. 24511:

\$543,618 to the Police Department to hire an additional 15 officers in 1990 for a total of 40 additional officers in the next budget year. The 15 officers are to be added on a phased-in basis:

1st quarter - 6 2nd quarter - 6 3rd quarter - 1 4th quarter - 2

 This funding will pay for salaries, benefits, uniforms, equipment, vehicles, jail, LESA, and property room costs.

Seconded by Deputy Mayor Hyde.

Council Member Mykland read concerns from a petition submitted by south end neighbors and other residents concerned with crimes in the region and then filed the letter with the City Clerk.

Deputy Mayor Hyde moved to amend Council Member Mykland's amendment to add five additional police officers to the 1990 budget in the first quarter at a cost of \$260,185, the remaining \$283,433 be set aside in the Law Enforcement Contingency Fund to be allocated by the City Council in 1990.

Voice vote was taken and carried. The motion was declared adopted.

Council Member Nielsen moved to amend the preceding motion by reducing the remaining balance from \$283,433 set aside in the Law Enforcement Contingency Fund to a revised amount of \$268,246.

Roll call vote was taken, resulting as follows:

Ayes: 8 - Hyde, McElliott, Moss, Nielsen, Stenger, Vialle, Warnick, and Mayor Sutherland.

Nays: 1 - Mykland.

The motion was declared adopted.

Roll call vote was taken on the amendments to the budget resulting as follows:

Ayes: 9 - Hyde, McElliott, Moss, Mykland, Nielsen, Stenger, Vialle, Warnick, and Mayor Sutherland.

Nays: 0.

The amendments to the budget were declared adopted.

Mayor Sutherland appointed Council Members Vialle, Stenger, Mykland, and Warnick to a committee to meet with financial institutions regarding the B&O tax increases recently enacted.

Council Member Vialle stated that she would serve as chair of the committee and set up the first meeting.

Voice vote was taken and carried. The Substitute Resolution, as amended, was declared adopted.

COMMENTS AND COMMITTEE REPORTS OF CITY COUNCIL:

Council Member Warnick stated that the Bing Crosby Historical Society would like to continue using the Pantages Basement for one more year and indicated he would bring a resolution for Council consideration next week.

Council Member Warnick stated that he had noticed that there were many vacant spots for study session topics at the beginning of next year and suggested that the capital improvements bond issue might be a subject along with Goodwill Games briefing committee.

Council Member Mykland stated that he thought it prudent to delay discussion of the bond issue until after the vote had been taken in February and then perhaps bring it up again on the March study session schedule.

The City Clerk is also directed to fulfill all public notice requirements. Seconded by Council Member Vialle. Voice vote was taken and carried. The motion was declared adopted.

Deputy Mayor Hyde moved to continue the appeal of David Pitts (File Nos. 130.3176 and 131.129) originally scheduled for December 19, 1989 to January 16, 1990 at 5:30 p.m. Seconded by Council Member Mykland. Voice vote was taken and carried. The motion was declared adopted.

The appeal was continued to January 16, 1990.

Deputy Mayor Hyde moved to recess to Executive Session to discuss litigation, the session not to exceed 15 minutes. Seconded by Council Member Stenger. Voice vote was taken and carried. The motion was declared adopted.

Council recessed to Executive Session at $7:29~\mathrm{p.m.}$ and reconvened at $7:44~\mathrm{p.m.}$

Deputy Mayor Hyde moved that the City Council approve a settlement in the case of Daniel Belsvig v. City of Tacoma, Pierce County Cause No. 85-2-04586-1, in accordance with the terms presented to the City Council in Executive Session, and that the City Manager and the appropriate City officials are authorized to take such action and execute such documents as are required to effect the settlement. Seconded by Council Member Stenger. Voice vote was taken and carried. The motion was declared adopted.
