#### REPORTS BY CITY MANAGER

City Manager Ray E. Corpuz Jr. asked the City Council to check the dates that have been proposed to them as to which City Council meetings they would like to cancel for the remainder of the year.

#### COMMENTS AND COMMITTEE REPORTS OF CITY COUNCIL

Council Member Silas spoke to her constituents from the Hilltop area recognizing there is a problem. She stated there is an opinion among some of her constituents that the elected officials do not care. Council Member Silas stated that she wants people to know that this City Council listens and that they do care. She requested that her fellow City Council Members meet on this subject and discuss the problem to improve the relationship between her constituents and the City Council.

Council Member Miller stated that he understands Council Member Silas' comments. He stated that some of the comments that were made tonight he agrees with and some of the comments he adamantly disagrees with. He stated that he doesn't think anybody sitting at the dais pretends to know the truth in this case, but he does agree with Council Member Silas in that when we have a problem we have to acknowledge it. He stated that the City Council is ready to join with Council Member Silas in meeting with the community in a positive manner to start looking for the solutions.

Council Member De Forrest suggested holding Town Hall meetings again in the different City Council Districts as a way to begin improving the relationship between the City Council and the citizens.

Council Member McGavick agreed with Council Member De Forrest. She stated that she feels the pain of those who have lost loved ones. She stated that having a Town Hall meeting in the Hilltop area would be a good start.

Council Member Phelps stated that he tries to discourage racism and teaches his own children not to practice it. He stated that the saddest thing would be to take this very tragic incident and not channel it into a positive vision of change, which can be done in a lot of different ways. He stated that he was concerned that the audience mistakenly took the Mayor's comments, which had to be made about the issues, as his not being concerned. He stated that the Mayor is very concerned about all of Tacoma. Council Member Phelps then stated that Thursday, May 6, 1999, is a national day of prayer.

Mayor Ebersole stated that there was legitimate concern tonight about bigotry and racism in America. He stated that the City Council does not feel qualified to sit in judgment on this particular case and feels uncomfortable when that particular case is mixed with a discussion about whether or not there is racism and prejudice in America. Mayor Ebersole stated that he agrees that when you have this many people, who believes there is a significant problem, the City Council has a responsibility to continue to dialogue and review the issue.
