Council Member De Forrest stated that on the Discovery Channel, the Justice Files program did a piece on Domestic Violence and the problem throughout the country. He stated that the City of Tacoma was mentioned as one of the areas that is trying to do something about the problem. Council Member De Forrest stated that the City of Tacoma is the only city, in the country, that has a mandatory three-month sentence.
