City Finance Director, Earl Mittelstaedt made a detailed presentation of the Annual Budget incorporating the previously agreed to changes within the budget. He noted that the increase cost of the General Fund was 8.56% and that the budget, as presented, was balanced.

Mayor Johnston indicated to members of the Council that he intended to send best wishes and encouragement to the Sumner Football Team which plays for the State Triple AAA Championship Saturday in Seattle.

Mayor Johnston then made a motion to excuse those members of the Council who are attending the National League of Cities meeting in San Francisco next week. Seconded by Councilman Nielsen. Mayor Johnston indicated that all but Councilmen Nelson and Hudson would be making the trip. Voice vote was taken and carried unanimously.



Councilman Strege made a motion that the City Council endorse the effort of the Task Force on Youth Safety and refer submitted recommendations to the Joint Municipal Action Committee. Seconded by Mr. Sonntag. Following additional discussion however, Councilman Strege withdrew the motion, with permission of the second, and asked that each Council member study the information submitted and be prepared to make some recommendations at next weeks meeting.
