

MINUTES OF CITY COUNCIL BUDGET HEARING

City Council Chambers
November 15, 1984

Mayor Sutherland called the hearing to order at 5:09 p.m.

Council members present: 8 - Bichsel, Hyde, Ladenburg, Rasmussen, Stenger, Strege, Warnick, and Mayor Sutherland. Absent: 1 - Kirby.

Mayor Sutherland announced that the purpose of the public hearing was to review the 1985 Preliminary Budgets for the Tacoma-Pierce County Humane Society, Law Enforcement Support Agency, Tacoma-Pierce County Health Department, Tacoma Public Library, and the Tacoma Metropolitan Park District.

The Mayor announced that copies of the 1985 Preliminary Budget for the Tacoma Public Library are available to the public and will be provided to those who desire them.

Mayor Sutherland announced that this was a regular, advertised, public hearing and that notice was duly published and should be incorporated by reference in the record.

At 5:11 p.m., Mr. Gary Aleshire, Director of Finance for the Tacoma-Pierce County Humane Society presented the department's budget for 1985.
