Amending Chapter 1.28 of the Official Code by adding a new section to be known as Section 1.28.130 which authorizes the Civic Arts Commission to accept donations and gifts of works of art.

Ordinance No. 22341

Appropriating \$16,000, or so much thereof as may be necessary, from the Federal Shared Revenue Fund for participating in the El Cid Program and declaring an emergency making necessary the passage of this ordinance and its taking effect immediately upon publication.

Declaring the intent of the proper officers of the City to establish a Financial Code of Ethics.

Councilman Strege moved to continue the Resolution for one week when Councilman Rasmussen would be back. Seconded by Councilwoman Bichsel. Voice vote was taken and carried. The Resolution was continued for one week.

PUBLIC HEARING:

This is the date set for public hearing on proposed amendments to the Zoning Ordinance to grant the Hearings Examiner authority when reviewing Special Property Uses to allow the height of a building to exceed that which is set forth in the underlying zoning district.

Rod Kerslake of the Planning Department explained the background and reasons for this request.

After questions by council members, Mayor Parker called for public testimony.

CITIZEN'S REQUEST TO BE HEARD:

Howard R. Smith requesting to speak on removing the Storm Draininge Utility.

Howard Smith, 1032 East 62nd, spoke on the Storm Drainage Utility and sumitted petitions against the Utility with approximately 2,812 signatures.

Councilman Strege moved to suspend the rules to allow the people in the audience to speak on this subject. Seconded by Councilwoman Bichsel. Voice vote was taken and carried.
