REPORTS BY CITY MANAGER:

City Manager Ray E. Corpuz, Jr. introduced Peter Katich from Building and Land Use Services Division who will be serving as the Special Assistant in the City Manager's Office for the next three months.

Mr. Corpuz requested an Executive Session to consider pending litigation, not to exceed 45 minutes.

COMMENTS AND COMMITTEE REPORTS OF CITY COUNCIL:

Deputy Mayor Silas indicated that she shares the views of the other Council Members regarding the Running Wolf Smoke Shop. She then stated that she would like to invite Tribal Members to a meeting and bridge the communication gap.

Mayor Ebersole reappointed Sinoun Hem-Joyce as Commissioner of the Tacoma Housing Authority, for a term commencing on April 1, 1996, and terminating on March 31, 2001.

Council Member Baarsma spoke regarding the meeting sponsored by the Rainier Cable Commission, TCI, and Viacom. He stated that Channel 13 is moving to Seattle and there will be an opportunity to utilize that facility as a regional site for cable television and PEG Access. Mr. Baarsma stated that representatives from most of our sister city committees throughout Pierce County and the County Council Members were there to review the site and the facility that would be available.

Council Member Kirby spoke regarding the testimony relative to the Running Wolf Smoke Shop and expressed his frustration regarding things the City could not do. He requested that the City aggressively pursue creative avenues in order to protect the citizens of Tacoma.

Council Member De Forrest thanked Mr. Randy Lewis for an excellent job in representing the City of Tacoma regarding the Running Wolf Smoke Shop. He stated that he was somewhat encouraged by the Supreme Court Ruling on the Indian Casino problem invoking the 11th Amendment of the United States Constitution in a 5-4 vote stating that the Federal Government cannot sue the States on behalf of Indian Tribes. Mr. De Forrest stated that maybe the Tribal Council and other Indian Nations will not be able to sue the City of Tacoma. He stated that Justice Stevens also said that the majority opinion has put in jeopardy the environmental lawsuits of the Federal Government. He stated that the City Attorney will be doing a further analysis of that decision. Council Member De Forrest stated that on April 6, 1996, Cambodian New Year will be celebrated at 7:30 p.m. at the Fellowship Hall on 47 St. Helens Street.

Council Member Miller moved to convene to Executive Session to consider pending litigation, not to exceed 45 minutes. Seconded by Council Member Evans. Voice vote was taken and carried. The motion was declared adopted.

Council convened to Executive Session at 7:10 p.m.

At 7:55 p.m., Mayor Ebersole extended Executive Session for 15 minutes.

Council reconvened at 8:06 p.m.

On proper motion, the meeting was adjourned at 8:06 p.m.
