Appropriating \$11,000 from the Visitor & Convention Promotion Fund and authorizing the execution of an amendment to the 1993 agreement with the Tacoma-Pierce County Visitor and Convention Bureau for film marketing and promotion services, and declaring an emergency making necessary the passage of this ordinance.

#### **REPORTS BY CITY MANAGER:**

Ray E. Corpuz, Jr., City Manager, stated that he was informed by the Municipal Court Judges that they had made their selection on a Night Court Commissioner. They had selected Dennis H. Ball. He also stated that on tomorrow's CityLine the Fire Chief, as well as the department educator, Charlie Hansen, will talk about different Fire Department activities. He reminded the Council that this Thursday is the retirement party forTed Coates.

## COMMENTS AND COMMITTEE REPORTS OF CITY COUNCIL:

Council Member McElliott reported on her recent trip to Jackson, Mississippi, where she attended the Neighborhood Awards as part of the Neighborhood's USA Conference. She noted that at the conference, Elton Gatewood, of the Planning and Development Services Department, was honored by the President of Neighborhoods USA by being given a special recognition as one of NUSA's most distinguished board members.
