Councilman Rasmussen moved that the Resolution be adopted. Seconded by Councilman Hyde. Voice vote was taken and carried. The Resolution was declared adopted.

Mayor Sutherland moved to place Item 12, "Public Hearings and Appeals," at the end of the Agenda to be considered as close to 6:00 p.m. as possible. Seconded by Councilman Hyde. Voice vote was taken and carried.

Deputy Mayor Nielsen moved to consider Item 16, "Citizens' Request to be Heard." Seconded by Councilman Rasmussen. Voice vote was taken and carried.

CITIZENS' REQUEST TO BE HEARD:

David R. Tuell, Jr., Director of the Western Washington American Bowling Congress, spoke regarding holding the 1986 American Bowling Congress Tournament and Convention in the Tacoma Dome. City Council Minutes - Page 7 - September 7, 1982

Mayor Sutherland moved to suspend the rules to allow the film of the American Bowling Congress to be shown to the Council. Seconded by Councilman Hyde. Voice vote was taken and carried.

Mr. Garland Smith, President of the American Bowling Congress, spoke regarding this matter prior to the showing of the film. The film was then shown to the Council.

Mayor Sutherland said that the Council would have an answer for the American Bowling Congress regarding submitting a letter of intent to hold the American Bowling Congress Tournament for 1986 at the Tacoma Dome by September 14, 1982. Mayor Sutherland then instructed staff to review this issue and discuss the matter with the City Council so they can respond to the American Bowling Congress by Tuesday, September 14, 1982. Art Childers, Secretary of the American Bowling Congress spoke and stated that this date would be acceptable to the Congress.

Deputy Mayor Nielsen also requested that the City Attorney review the use of the facility on a rent-free basis to see if this constitutes a gift of public funds.

PUBLIC HEARINGS AND APPEALS: (6:00 p.m.)

This is the date set for hearing the appeal of Park Ryker regarding the decision of the Hearings Examiner to approve the reclassification of the property located at the northeast corner of 49th Avenue N.E. and 33rd. Street N.E. from a "C-1" to an "R-4-LT" District as requested by the City of Tacoma.

Mr. Kerslake reported that there were a number of changed circumstances regarding the matter under appeal and recommended that the Council remand this item back to the Hearings Examiner for further consideration.

Mayor Sutherland moved to remand this matter back to the Hearings Examiner. Seconded by Councilman Hyde. Voice vote was taken and carried. The parties will be notified of Council action and when a new hearing date before the Hearings Examiner has been set.

COMMENTS AND COMMITTEE REPORTS BY MEMBERS OF THE CITY COUNCIL:

Mayor Sutherland announced that Council rules state that if Tuesday of any week should fall on the same day that either a primary or general municipal or state election is held, the regular meeting of that week shall be held at 5:00 p.m. on the first business day following, in place of Tuesday.

Councilman Hyde reported on the Health Board meeting he attended. He requested that various items be added to the City's legislative position statement concerning pollution including a request to the State for matching funds for pollution studies and a general statement on pollution and the need for regional approach to this matter. He also mentioned that the Health Department will be briefing the Council on sewage hookup problems along the Sound.

Deputy Mayor Nielsen moved to excuse Councilman Hyde from next week's meeting. Seconded by Mayor Sutherland. Voice vote was taken and carried.

Deputy Mayor Nielsen reported on a letter received in the Pierce County Assessor's Office regarding property located on South 72nd Street and South Puget Sound Avenue.

Mayor Sutherland announced that the City Council and the Public Utility Board will be conducting a public meeting on Thursday, September 16, 1982, at 7:00 p.m. and invited members of the public to attend and participate. The meeting will be held at the Bicentennial Pavilion.

Mayor Sutherland called for a special meeting of the City Council on September 13, 1982, at 6:00 p.m. The Council will call the meeting to order and then recess into Executive Sesssion for purposes of discussing personnel. The meeting will be held in the Training Room on the 6th Floor of the Tacoma Municipal Building. The Mayor requested that notice of the special meeting be given.

Mayor Sutherland moved to recess into Executive Session for purposes of discussing legal matters. Seconded by Councilman Hawkins. Voice vote was taken and carried. The Council recessed at 6:18 p.m. and reconvened at 6:54 p.m.

The Chair moved to approve the claim of Karl K. Thierbach for damages due to sewer back-up in the amount of \$4,752.84. Seconded by Deputy Mayor Nielsen. Voice vote was taken and carried.

On proper motion, the meeting adjourned at 6:55 p.m.
