Deputy Mayor Strege stated for the record that this would be the Council intent on this Resolution, provided that funds are available and provided there are successful, positive program reviews and that the contracts shall be continued for up to a three-year period of time.

# COMMENTS AND COMMITTEE REPORTS BY MEMBERS OF THE CITY COUNCIL:

Council Member Hyde requested that the City Manager's Office check with the Public Works Department and the Health Department regarding the demolition at the ASARCO plant. He expressed concern that not all environmental safeguards are being met. He also expressed concern that chemicals associated with the water and air, and disposal of the buildings be investigated. He stated that he would like reassurance that there are no problems with the demolition and disposal at the ASARCO site.

Erling O. Mork, City Manager, stated that the City does not have jurisdiction in all areas at that site, but that the Pierce County Health Department does, and that he would have the matter investigated.

Council Member Hyde stated that he would like to have the buildings investigated that are located within the Tacoma city limits.
