RESOLUTIONS

Resolution No. 36574

Setting Tuesday, July 19, 2005, at approximately 5:30 p.m., as the date for a public meeting by the City Council regarding the annexation of property located at 5006 Varco Road NE in unincorporated Pierce County.

FIRST READING OF ORDINANCES

Ordinance No. 27380

Amending Chapter 13.06 of the Municipal Code to reclassify the property located at 614 South Adams from an "R-2" One-Family Dwelling District to a "T" Transitional District for the development of a small park and a 12-stall, off-street parking area. (Snodgrass Freeman Associates for Gray Lumber, Sixth Avenue; File No. 40000043058)

Ordinance No. 27381

Vacating the alleyway between East C and East D Streets abutting Puyallup Avenue and East 25th Street to relocate the loading facilities to the rear of the building. (Joanita Enterprises, LLC; File No. 124.1236)

Ordinance No. 27382

Vacating a 30-foot strip of East N Street between the south line of East 46th Street and the north line of East 48th Street, to combine the vacated right-of-way with the abutting property and develop a subdivision on the property for affordable home ownership housing. (Habitat for Humanity; File No. 124.1239)

Council Member Lonergan moved that the Consent Agenda, including Resolution No. 36574 and Ordinance Nos. 27380 through 27382, be approved. Seconded by Council Member Talbert.

Council Member Lonergan moved to concur in the Findings, Conclusions and Recommendations of the Hearing Examiner for Ordinance Nos. 27380 through 27382. Seconded by Council Member Talbert. Voice vote was taken and carried. The motion was declared adopted.

Voice vote was taken and carried on the Consent Agenda. The Consent Agenda, including Resolution No. 36574 and setting Ordinance Nos. 27380 and 27382 over for final reading to a date to be determined, was declared approved.

FINAL READING OF ORDINANCES

Ordinance No. 27376

Providing for the submission to the voters of the City at a special election to be held on Tuesday, September 20, 2005, a proposition authorizing the issuance of general obligation bonds in a total principal amount not to exceed \$45,000,000, for the purpose of providing improvements to the Tacoma Dome, to read as follows:

PROPOSITION NO. 1 TACOMA DOME RENOVATION AND IMPROVEMENT

The Tacoma City Council passed Ordinance No. 27376 concerning a proposition relating to the Tacoma Dome.

If approved, this ballot proposition would allow the City to renovate and improve the Tacoma Dome, issue up to \$45,000,000 of general obligation bonds maturing within 25 years to finance such renovations and improvements, and levy annual excess property taxes to pay and retire the bonds, all as provided in Ordinance No. 27376. Should this proposition be:

Ordinance No. 27377

Amending the Video Voters' Pamphlet Administrative Rules and Regulations for the primary, general, and special elections.

Ordinance No. 27378

Amending Title 13 of the Municipal Code, by repealing Chapter 13.14 in its entirety, to sunset the Environmental Commission.

Roll call vote was taken, resulting as follows:

FIRST READING OF ORDINANCES

Ordinance No. 27383

Amending Chapter 1.12 of the Municipal Code, relating to the Compensation Plan, to implement rates of pay and compensation negotiated with the Tacoma Fire Fighters Union, Local 31, for 388 employees, effective January 1, 2004 through December 31 2005.

The Ordinance was set over for final reading next week.

Ordinance No. 27384

Amending Chapter 1.12 of the Municipal Code, relating to the Compensation Plan, to implement rates of pay and provisions of a letter of understanding negotiated with the International Association of Machinists and Aerospace Workers, District Lodge 160, on behalf of Local Lodge 297, General Unit; changing titles for three classified classifications; changing the classification of Transmission & Distribution Supervisor; creating a new classified title of Crime Scene Technician; and changes in classifications to reflect the organizational structure.

The Ordinance was set over for final reading next week.

Ordinance No. 27385

Providing for the submission of a proposition to the qualified voters of the City at the November 8, 2005, general election, for their rejection or approval, to authorize a six-year increase in the regular property tax levy and to impose an additional regular property tax levy to finance affordable housing for low- and very low-income households; and declaring the existence of an emergency to read as follows:

PROPOSITION NO. 1 Low-Income Housing Levy

The City of Tacoma's Proposition 1 concerns property tax levies for affordable housing purposes proposed by Ordinance No. 27385.

This proposition would allow the City to fund affordable housing by (a) imposing an additional regular property tax levy of \$1,950,000 annually (\$0.14/\$1,000 of assessed value) for six years; and (b) increasing its regular property tax levy by \$2,500,000 to \$3.60/\$1,000 of assessed value in 2006, and increasing the levy amount by 4% in each of the five succeeding years. The maximum dollar amount in year six shall be used to compute the RCW 84.55.010 limitations thereafter.



Those in favor shall mark their ballots "Yes"; those opposed shall mark their ballots "No."

The Ordinance was set over for final reading next week.

Awarding contracts to:

- 1. Advanced Equipment Corporation, in the amount of \$432,720.00, plus sales tax, for the removal and replacement of operable walls at the Bicentennial Pavilion Specification No. PW05-0174F;
- Site Development, Inc., on its bid of \$450,539.84, including sales tax, for the construction of a soil preload embankment at the Tacoma Landfill – Specification No. PW05-0339F; and
- 3. Midmountain Contractors, Inc., on its bid of \$2,825,030.00, sales tax not applicable, for the construction of the Downtown Redevelopment Streetscape Improvement Project Specification No. PW05-0100F.

Council Member Lonergan moved that the Purchase Resolution be adopted. Seconded by Council Member Talbert. Voice vote was taken and carried on the Purchase Resolution. The Purchase Resolution was declared adopted.

Resolution No. 36576

Authorizing the execution of a two-year agreement with Motorola, Inc., in the amount of \$190,000, to provide system support and maintenance services for the 800 Megahertz Public Safety Radio System Project.

Council Member Lonergan moved that the Resolution be adopted. Seconded by Council Member Talbert. Voice vote was taken and carried. The Resolution was declared adopted.

Resolution No. 36577

Authorizing the execution of an agreement with the Washington State Military Department, Emergency Management Division, in the amount of \$60,176, to conduct an increased level of emergency management planning and training activities in 2005.

Council Member Lonergan moved that the Resolution be adopted. Seconded by Council Member Anderson. Voice vote was taken and carried. The Resolution was declared adopted.

Resolution No. 36578

Authorizing the execution of a Collective Bargaining Agreement negotiated with the International Brotherhood of Electrical Workers, Local 483, Clerical Unit, for 171 employees, effective January 1, 2005 through December 31, 2005.

Council Member Lonergan moved that the Resolution be adopted. Seconded by Council Member Talbert. Voice vote was taken and carried. The Resolution was declared adopted.

Resolution No. 36579

Authorizing the execution of a Collective Bargaining Agreement negotiated with the International Brotherhood of Electrical Workers, Local 483, Customer and Field Services Unit, for 130 employees, effective January 1, 2005 through December 31, 2005.

Council Member Lonergan moved that the Resolution be adopted. Seconded by Council Member Talbert. Voice vote was taken and carried. The Resolution was declared adopted.
