CITY COUNCIL MINUTES

City Council Chambers August 30, 1977 261

The meeting was called to order at 5:05 p.m.

Present on roll call: 8 - Bichsel, Hudson, Nelson, Nielsen, Schroeder Strege, Warnick and Mayor Johnston. Absent: 1 - Sonntag. Mr. Sonntag arrived at 5:07 p.m.

The Flag Salute was led by Mr. Hudson.

Mayor Johnston moved to suspend the rules in order to hear Item No. 17 on the agenda - Citizens Requests to be Heard - prior to the Consent Agenda. Seconded by Mr. Sonntag. Voice vote was taken and carried.

Don McGavick said he was representing the citizens who signed a petition regarding traffic problems on Sixth Avenue in the vicinity of Pearl and Mildred. He asked that a frontage road between the proposed freeway, SR-16, be constructed at the rear of the commercial district between Pearl to Mildred, to alleviate traffic congestion as a result of the proposed SR-16 in that area. He presented a petition with 1300 signatures.

Also speaking and answering questions of Council members was Bob Anderson, retired Director of Public Works.

Mayor Johnston moved to suspend the rules to have Public Hearing which is Item No. 13 on the agenda heard next. Seconded by Mr. Nielsen. Voice vote was taken and carried.

PUBLIC HEARINGS:

Public hearing on proposed State Route 509 - Tacoma Spur.

J. D. Zirkle, Director of the Highway Engineer for the State of Washington, reviewed the proposed route of the Spur which would connect the downtown to the Interstate 5. The proposal was to cross the City Waterway in the vicinity of 20th Street. City Council Minutes - Page 2 - August 30, 1977

Also speaking were: Don Barber, Executive Vice President of the Tacoma Area Chamber of Commerce who asked that consideration be given for vehicle traffic to Dock Street; David Williams, Member of the Board of Trustees of the Downtown Tacoma Association; and Clyde Hupp, Secretary of the Pierce County Central Labor Council; and Richard Vincent, representing the Burlington Northern Railroad, who had concerns regarding the Spur as relates to the Tacoma Union Depot, he asked that the railroad have an opportunity to review the proposed project.

With no further public comments, Mayor Johnston declared the hearing closed.

COMMUNICATIONS:

a. Tacoma Library Board of Trustees advising the Council of their interest in a joint venture of a Branch Library and Fire Station in Northeast Tacoma.

Cyril J. Galagan, President of the Tacoma Library Board of Trustees, described to Council the Library Board's proposal of a joint library and fire station on property which had been donated to the Library Board. He spoke of the advantages of such a venture.

Tony Mitchell, Chief of the Tacoma Fire Department, answered questions of Council members in regard to his impression as to the values of the proposal.

No action was taken by the Council.

b. City Attorney requesting that the file on George S. Pessemier's request for the reclassification of the Southwest corner of South 12th Street and Puget Sound Avenue from an "R-2" to an "R-2-T" District be closed and Ordinance No. 20472 be tabled.

Mr. Schroeder moved to concur in the request of the City Attorney. Seconded by Mr. Nielsen. Voice vote was taken and carried.

FINAL READING OF ORDINANCES:

Mr. Mork referred to prior discussions at a Study Session on the Puget Mini-Park and to material received by them on the subject. He asked that Council review the subject at this time as several concerned citizens are present.

Ron Button, Director of Public Works, introduced Karen Dennis, Public Works Department Engineer who reviewed the modified site plan of the proposed project which includes a Big Toy area, picnic area and asphalt paths.

Speaking against the project were: William Good, 3738 No. 31st; Laurie Johnson, 3912 No. 31st; Mrs. Ned Nelson, 3744 No. 31st; Rebecca Madsen, 3722 No. 31st; Ruth Johnson, 3912 No. 31st.

Speaking in favor of the project was: Carol Gorsuch 7302 North 27th. A petition signed by 30 residents, against the project was given to the City Manager.

Mr. Sonntag suggested instructing the City Manager to proceed with the revised preliminary site plan. Mayor Johnston asked that a resolution be brought to the Council.
