# COMMENTS AND COMMITTEE REPORTS OF CITY COUNCIL

Mayor Baarsma requested a report from the Fire Chief in the Thursday Letter regarding a harbor fire in Seattle.

Council Member Phelps moved to excuse Deputy Mayor McGavick and Council Member Moss from tonight's meeting. Seconded by Council Member Miller. Voice vote was taken and carried. The motion was declared adopted.

Council Member Evans attended the dedication of the new Marine Discovery Lab at the Point Defiance Aquarium, which is a collaborative effort between the City and environmental services. He complimented Bill Pugh, Karen Larkin and Linda Farmer for their efforts. He stated the lab will educate over 900 fourth graders during the next school year and that 10,000 people are expected to visit.

Council Member Evans stated last Saturday he attended the 10<sup>th</sup> Anniversary of the Cross District Association, which represents the 12 urban villages of the City. He thanked Mariza Craig and her staff for their efforts. He stated over 100 merchants were there representing all the cross sections from Fern Hill to Old Town.

Council Member Lonergan stated TACID's annual meeting will be held May 22, 2002, at 6:30 p.m.

Council Member Lonergan stated that last Wednesday he attended the American Red Cross RSVP Breakfast. He stated awards were given to Audrey Anderson for 26 years of service with the Red Cross; Betty Drost for volunteering since the 1940s in our community, especially in education; Mary Long for 20 years of service at DeLong Elementary; and the 2,000 Paint Tacoma-Pierce Beautiful volunteers.

Council Member Ladenburg stated last Saturday Safe Streets had its annual March Against Drugs and Violence. She thanked the Firefighters Union for donating signs and the Mayor for attending and speaking to the youth.

Council Member Phelps stated last Tuesday evening the Council attended the City of Destiny awards. He stated to the City Manager that staff did a wonderful job, especially Community Relations and Tacoma TV.

Mayor Baarsma reported on his trip last week to Washington D.C., where he met with Congressmen Dicks and Smith and Senators Cantwell and Murray. He delivered a letter stating Tacoma has reasonable alternatives to putting the jersey barriers on Pacific Avenue. He stated Congressman Dicks asked to have a meeting with the representatives of GSA to discuss the options. Mayor Baarsma stated he discussed with the delegation a number of public works and economic development issues, particularly the Small Business Initiative campaign. He stated Congressman Dicks is excited about the Train to the Mountain and that there may be some money in the Interior Budget for that.

Mayor Baarsma reminded everyone that the City Council study session and meeting for Tuesday, May 28, 2002, have been canceled and that the next regularly scheduled meetings would be held on Tuesday, June 4, 2002, at noon and 5 p.m., respectively.
