Adopting the Six-Year Comprehensive Street Program for 1984 through 1989.

Councilman Rasmussen moved that the Resolution be adopted. Seconded by Councilman Kirby.

Councilman Kirby moved to amend Page 3, Item 1B of the Draft Plan to reflect the amount of \$50,000 from one-half cent gas tax funds. Seconded by Councilman Rasmussen. Voice vote was taken and carried. The motion was declared adopted.

Councilman Kirby moved to amend Page 3, Item 1D of the Draft Plan to reflect the amount of \$20,000 in the one-half cent gas tax column. Seconded by Councilman Strege. Voice vote was taken and carried. The motion was declared adopted.

Councilman Kirby moved to amend the Resolution by adding after the last word "... provided, however, that the Comprehensive Street Program for the years 1984 through 1989 will be brought back to the City Council for further consideration in the event that the City of Tacoma is unsuccessful in acquiring the necessary UAB Funds required to complete the Portland Avenue Project."

After further discussion, a friendly amendment was added to read as follows:

"provided, however, that the Comprehensive Street Program for the years 1984 through 1989 will be brought back to the City Council for further consideration no later than November of 1983."

Voice vote was taken and carried. The motion, as amended, was declared adopted.
