### COMMENTS AND COMMITTEE REPORTS OF CITY COUNCIL:

Mayor Vialle moved to excuse the absence of Deputy Mayor Mykland. Seconded by Council Member Moss. Voice vote was taken and carried. The motion was declared adopted.

Council Member Nielsen requested staff to prepare a resolution on the realignment of terms for Planning Commission members as defined in the June 25, 1993 memo from Norris Bacho, Director of Planning and Development Services.

Council Member Miller commended Mayor Vialle for her appointment to the Advisory Board of the U.S. Conference of Mayors. Council Member Miller also commended staff for the excellent brochure depicting the economic efforts of the City.

Council Member Evans indicated that he had been in contact with McChord Air Force Base concerning the jet fire noise over the north end of Tacoma. He stated that McChord indicated that the Oregon National Guard will be operating fire jets through September and suggested to send a letter expressing the noise concerns. Council Member Evans commended Cecelia Funkhouser, of Planning and Development Services, for her efforts in handling a delicate situation with a visiting Chinese delegation on a matter concerning human rights.

Council Member Baarsma reported on the Association of Washington Cities Conference that he and other Council Members attended. He stated that he served on a resolution committee to develop upcoming policies for the next year. He also stated that he served on a panel to discuss the success of the Safe Streets Program. Council Member Baarsma indicated that the Association of Washington Cities passed 28 resolutions. The resolutions that would be of interest for Tacoma include the hands off Washington campaign, gun control and the impacts of Initiative 601 and 602.

Mayor Vialle moved to recess to Executive Session to discuss potential and pending litigation, the session not to exceed 30 minutes. Seconded by Council Member Miller. Voice vote was taken and carried. The motion was declared adopted.

Council recessed to Executive Session at 8:05 p.m. and reconvened at 8:30 p.m.
