a. City Attorney submitting proposed alternatives on the decision of the appeal of Champion International Corporation regarding Audit Assessment Notice AD5109 (File No. T-52940).

Robert Backstein, City Attorney, reviewed the circumstances regarding the appeal and stated that he had submitted a memo to the Council outlining the possible options.

Mayor Sutherland read into the record the three possible motions under discussion from the City Attorney's memo.

Council Member Harnick moved to modify the decision of the Hearings Examiner by concurring with his decision on the taxes for the reasons set forth in the Hearings Examiner's decision, but moved to modify specifically the decision of the Hearings Examiner with regard to statutory interest and penalties by deleting the following amounts: \$11,609.51 for tax penalty, for the reason that, due to actions by both the City and the taxpayer, confusion and delay were created with regard to whether the amount of taxes was in fact due, thereby allowing fiffffff ind/of penalties to be placed upon this assessment, and, for that reason, the jnfffff of penalties should be reduced as set forth above, on the condition that the matter not be appealed. If appealed, however, the waiver of the penalty would not be granted, and the court should decide all of the issues.

The motion was seconded by Deputy Mayor Rasmussen. Voice vote was taken and carried, with Council Member Mykland voting "Nay," and Council Member Hyde abstaining. The motion was declared adopted.

b. City Attorney requesting that the rezone files from Tacoma Inns, Inc.; File No. 120.936 and Department of Public Works, File No. 120.956 be withdrawn and terminated.

Mayor Sutherland moved to concur in the recommendation of the City Attorney. Seconded by Council Member Hyde. Voice vote was taken and carried. The motion was declared adopted.

c. City Attorney requesting that the street vacation request of John D. Ehrhart; File No. 124.763 be withdrawn and terminated.
