Authorizing the execution of Amendment No. 7 and Exhibit L to the Power Sales Contract with the Bonneville Power Administration to reduce the wholesale power purchases during August 1, 1996 through September 30, 2001.

Deputy Mayor Silas moved that the Resolution be adopted. Seconded by Council Member Miller. Voice vote was taken and carried. The Resolution was declared adopted.

## Resolution No. 33452

Authorizing the execution of a Surplus Power Sale Agreement with the Bonneville Power Administration for the purchase of power during August 1, 1996 through July 31, 2001 and selling an equivalent amount of power to Occidental Chemical.

Council Member Evans moved that the Resolution be adopted. Seconded by Deputy Mayor Silas. Voice vote was taken and carried. The Resolution was declared adopted.

## Resolution No. 33453

Authorizing the execution of an agreement with McClaren & Wilson, Inc., in the amount of \$97,500, for conducting a long-range facilities needs assessment and recommending a long-range facilities plan.

Designating the Fair Housing Practices Video Project as a Major Government Aid Project of limited duration to teach fair housing practices, including development and production of training videos. Council Member Crowley moved that the Resolution be adopted. Seconded by Deputy Mayor Silas. Voice vote was taken and carried. The Resolution was declared adopted.

#### Resolution No. 33455

Authorizing the execution of an agreement with Associated Ministries of Tacoma-Pierce County, in the amount of \$40,745, for the Paint Tacoma-Pierce Beautiful Project.

Council Member Crowley moved that the Resolution be adopted. Seconded by Deputy Mayor Silas. Voice vote was taken and carried. The Resolution was declared adopted.

#### Resolution No. 33456

Authorizing the execution of the Second Trust Amendment with the Metropolitan Park District to include the Harmon property in the Public Facility Development and Shoreline Lands Holding Trust Agreement.

Council Member Crowley moved to continue Resolution No. 33456 to the meeting of August 6, 1996, per the request of staff. Seconded by Deputy Mayor Silas. Voice vote was taken and carried. The motion was declared adopted.

**REPORTS BY CITY MANAGER** 

City Manager Ray E. Corpuz, Jr., respectfully requested an Executive Session to discuss contract labor negotiations, not to exceed 45 minutes.

#### COMMENTS AND COMMITTEE REPORTS OF CITY COUNCIL

Council Member De Forrest commented on the outdoor concert that was held in the Tacoma Dome parking lot. He stated that he received complaints regarding the noise level and the vulgar language. He asked whether or not the City could put something either in the contract or the policy to clean up the language.

Deputy Mayor Silas asked City Manager Ray E. Corpuz to update the viewing audience on how the selection of the new Police Chief was going.

City Manager Ray E. Corpuz, Jr., stated that at the end of last week a community group including the Mayor interviewed nine candidates, three of whom were internal

candidates from the Police Department and six external candidates. The six external candidates included Police Chiefs and Deputy Chiefs from cities that were either as large or larger than the City of Tacoma. Mr. Corpuz stated that the City is in the process of completing background checks, reference checks and following up on some of the issues that were discussed in the interviews. He stated that audio tapes are available to the City Council and that he would be available to discuss any concerns the City Council may have regarding the interviews. He stated that he intended to make his selection in approximately two weeks.

Mayor Ebersole stated that he had the opportunity to interview the nine finalists. He then stated that the three candidates from the Tacoma Police Department were excellent and commended the Police Department for having three high qualified candidates come forth. He stated that the Police Chiefs from Wichita, Fort Wayne and Milwaukee were also excellent. Mayor Ebersole stated that he is confident that the City of Tacoma will have a well qualified Chief of Police at the end of this process.
