Accepting \$488,532 from the Federal Aviation Administration and \$20,000 from the Washington State Department of Transportation; depositing \$508,523 into the Airport Construction Fund; transferring \$34,282 from the Airport Operating Fund to the Airport Construction Fund; and appropriating \$542,805 from the Airport Construction Fund for widening the apron at the Tacoma Narrows Airport.

Roll call vote was taken, resulting as follows:

Vacating a portion of the alley between Trafton and Steele Streets north of South 25th Street to incorporate the vacated area into the landscaping plan for a parking addition for the Puget Sound Bank's Computer Center. (Puget Sound Bank; File No. 124.953)

Mayor Vialle moved to concur in the recommendations of the Hearings Examiner. Seconded by Council Member Moss. Voice vote was taken and carried. The motion was declared adopted.

The Ordinance was set over for final reading to a date to be determined.

Ordinance No. 25113

Appropriating \$8,000 from the Stadium & Convention Center Trust Fund for the 1992 Spring Fest state high school athletic championship events; and declaring an emergency making necessary the appropriation herein.

The Ordinance was set over for final reading next week.

RESOLUTIONS:

Resolution No. 31743 (Continued from the meeting of May 12, 1992.)

Authorizing the execution of an amendment to the Limited Modification of the Settlement Agreement with the Puyallup Tribe of Indians to regulate vessel traffic during tribal gillnet fishing seasons in Commencement Bay.

Mayor Vialle moved to remove Resolution No. 31743 from the agenda. Seconded by Council Member Nielsen. Voice vote was taken and carried. The motion was declared adopted.

Resolution No. 31743 was removed from the agenda.

Resolution No. 31714 (Continued from the meeting of May 5, 1992.)

Adopting the "Thea Foss Waterway Design and Development Plan" as an element of the "Land Use Management Plan."

Deputy Mayor Mykland moved to continue Resolution No. 31714 to the May 26, 1992 agenda. Seconded by Council Member Moss. Voice vote was taken and the motion failed.

Mayor Vialle moved to suspend the rules to consider Resolution No. 31714. Seconded by Council Member Miller. Voice vote was taken and carried. The motion was declared adopted.

Mayor Vialle moved to adopt Substitute Resolution No. 31714. Seconded by Council Member Evans.

Council Member Miller moved to amend Substitute Resolution No. 31714 to include Attachment A, page 1, of the proposed changes to the Thea Foss Waterway Design and Development Plan. Seconded by Council Member Nielsen. Voice vote was taken and carried. The motion was declared adopted with Deputy Mayor Mykland voting in opposition.

Council Member Evans moved to amend the amended Substitute Resolution to incorporate the following language on page 137 of the Thea Foss Waterway Design and Development Plan,

"Encourage control techniques vary by degree of specificity and administrative requirements. When individual project review functions are not required, regulatory mechanisms take the form of uniformly applied controls, most commonly in the form of traditional zoning. Where project reviews are desired to ensure more sensitive compliance with the goals of the study area, the regulatory mechanism may involve special controls or zoning for these areas such as requiring parking within the footprint of the buildings and set backs of waterfront buildings to eliminate shadows on pedestrian ways."

Seconded by Council Member Baarsma. Voice vote was taken and carried. The motion was declared adopted.

The motion failed.

Voice vote was taken on the Amended Substitute Resolution No. 31714 and the motion carried. The Amended Substitute Resolution No. 31714 was declared adopted.

Voice vote was taken and carried on the Purchase Resolution. The Purchase Resolution was declared adopted.

Resolution No. 31753

Authorizing the execution of an easement in a portion of Norton Street with Kapowsin Community Water Company to allow construction and maintenance of a community water system.

Council Member Nielsen moved that the Resolution be adopted. Seconded by Council Member Silas. Voice vote was taken and carried. The Resolution was declared adopted.

Resolution No. 31754

Authorizing the execution of collective bargaining agreements with the International Brotherhood of Electrical Workers, Local 483, Water Division; Association of Machinist and Aerospace Workers, District Lodge No. 160, General Unit; Federation of Professional and Technical Engineers, Local 17; and Association of Machinist and Aerospace Workers, District Lodge No. 160, Belt Line effective January 1, 1993 through December 31, 1994.

Council Member Moss moved that the Resolution be adopted. Seconded by Council Member Baarsma. Voice vote was taken and carried. The Resolution was declared adopted.

Resolution No. 31755

Authorizing the execution of a collective bargaining agreement with the International Brotherhood of Electrical Workers, Local 483, Water Pollution Control Unit, effective January, 1993 through December 31, 1994.

Council Member Moss moved that the Resolution be adopted. Seconded by Council Member Evans. Voice vote was taken and carried. The Resolution was declared adopted.

Resolution No. 31756

Authorizing the execution of an amendment to the agreement with the Puyallup Tribe of Indians to provide utility and fire services to the Tribe's marina project at the inner Hylebos property located at 11th Street and Marine View Drive for a 30-year limitation period.

Council Member Evans moved that the Resolution be adopted. Seconded by Council Member Nielsen. Voice vote was taken and carried. The Resolution was declared adopted.

Resolution No. 31757

Authorizing the execution of lease agreements with Pizza Haven Incorporated in the amount of \$24,000 and H. D. Baker Business Systems in the amount of \$15,000 for advertising space in the Tacoma Dome.

Council Member Nielsen moved that the Resolution be adopted. Seconded by Council Member Miller. Voice vote was taken and carried. The Resolution was declared adopted.
