Deputy Mayor Stenger moved to adopt Substitute No. 1 to Ordinance No. 24606. Seconded by Council Member Nielsen. Council Member Evans moved to amend Substitute No. 1 to Ordinance No. 24606 to include the language contained in Substitute No. 2 to Ordinance No. 24606, on Page 5, Lines 11-12, by adding "Day-care centers in "R-1," "R-2," "R-2-SRD," and "R-3" Districts shall be limited to one building face sign with a maximum area of six square feet;" and on Page 3, Line 13-14, paragraph 2, "Day care centers located in "R-1," "R-2," "R-2-SRD," and "R-3" Districts shall be limited to one building face sign with a maximum area of six square feet." Existing language "Sign regulations for day-care centers located in, new language 'PRD' and multiple-family districts" and the existing language continues. Seconded by Deputy Mayor Stenger. Voice vote was taken and carried. The motion was declared adopted.

Voice vote was taken on Substitute No. 1 of Ordinance 24606, as amended, and carried.

The Substitute Ordinance was set over for final reading next week.

Ordinance No. 24607

Authorizing the execution of a grant award contract with the Department of Housing and Urban Development in the amount of \$63,000.00; and depositing and appropriating said sum from the Miscellaneous Grants Summary Fund for the Emergency Shelter Grant Program.

The Ordinance was set over for final reading next week.

Ordinance No. 24608

Authorizing the transfer of \$25,000.00 from the Contingency Fund to the General Fund; appropriating said sum from the General Fund; extending the agreement with Robert J. Backstein to serve as special counsel in litigation involving Initiative 62; and declaring an emergency making necessary the passage of this ordinance.

The Ordinance was set over for final reading next week.

Ordinance No. 24609

Authorizing the transfer of \$60,000.00 from the Contingency Fund to the General Fund; appropriating said sum from the General Fund; extending the agreement with Albert Malanca to serve as special counsel in litigation involving substantial tax revenue to the City of Tacoma; and declaring an emergency making necessary the passage of this ordinance.

The Ordinance was set over for final reading next week.

Ordinance No. 24610

Amending Section 1 of Ordinance No. 21255; and appropriating and transferring \$320,000.00 from the Tacoma-Pierce County Health Department Self Insurance Claim Fund to the Health Pooling Fund to replace funds lost by budget reductions by the City and County. The Ordinance was set over for final reading next week.

Ordinance No. 24611

Amending Ordinance No. 24570; authorizing the Mayor, City Manager or Director of Finance to execute a mortgage in connection with the City of Tacoma Lease Revenue Bonds (Tacoma Union Station Federal Courthouse Project), 1990; and ratifying and confirming prior acts consistent with this ordinance.

The Ordinance was set over for final reading next week.
