The meeting was called to order at 5:05 p.m.

Deputy Mayor Stenger moved that the Consent Agenda, including Resolution No. 30844, be approved. Seconded by Council Member Mykland. Voice vote was taken and carried. The Consent Agenda was declared approved.

Mayor Vialle proclaimed the week of April 22–28, 1990 as Earth Day Week, and presented the proclamation to Ms. Reba Bruni who presented an Earth Day Flag to the City Council.

Mayor Vialle proclaimed the month of April as Fair Housing Month and presented the proclamation to Mr. Michael Dolan of the Community Housing Board.

Mayor Vialle moved to recess to Executive Session to discuss pending and potential litigation, the session not to exceed a half hour. Seconded by Deputy Mayor Stenger. Voice vote was taken and carried. The motion was declared adopted.

Council recessed to Executive Session at 5:11 p.m.

Council Member Nielsen re-entered the Council Chambers at 5:39 p.m. and said the Executive Session would continue for another 15 minutes.

Council reconvened at 5:53 p.m.

Mayor Vialle read the following statement to the public and the press before moving on to Public Hearings and Appeals:

> "The City of Tacoma has used Urban Development Action Grant Funds to make a number of loans which have been successfully used to construct new facilties or to reconstruct and refurbish exising commercial buildings, to provide jobs and eradicate blighted conditions in the City of Tacoma. The Municipal Authority, which is a separate legal entity and a private corporation, has made similar loans using funds from other federal programs, commonly referred to as 108 Funds. Some of the projects on which loans were made include the Norton Clapp Law Center at the University of Puget Sound, Sheraton Hotel, Tacoma Financial Center, One Pacific Building and La Quinta Inn.

Recently, some questions have arisen regarding a loan made by the Municipal Authority to refurbish a building located at 15th and Pacific Avenue, 1501 Pacific to be precise. After consultation with the City Manager, we expect all City staff to continue to <u>cooperate</u> fully with the grand jury which is conducting an inquiry into that project.

We have requested that all City staff members cooperate fully with others, including the media, who have questions regarding that project or other aspects of the loan programs administered by the City of Tacoma's Community Development Department, to the extent that such disclosures will not hinder or prejudice the course of the grand jury or compromise current pending litigation that the City has to recover the amount loaned on the project at 15th and Pacific. We urge that the Municipal Authority, which is not a City entity as I indicated before, adopt a similar policy of cooperation with the grand jury and with those conducting other investigations.

The City Manager has directed, at the request of the City Council, that an <u>outside</u> management study be undertaken to ensure that the loan programs administered by our Community Development Department are administered fairly and in an even-handed manner, consistent with all City, state, and federal laws, rules and regulations. This study will be due back in 60 days to this Council. This study shall also make recommendations as to whether any changes should be made to ensure that the City's loan programs are administered in a more efficient and business like manner. This outside consultant will also verify that all materials requested by the grand jury have been made available to it."

This Council, and members of the City government, as indicated in this statement, will cooperate to the fullest extent possible in this investigation and this outside consultant will come back to us in 60 days and, at that time, we will have a further statement to make on recommendations and improvements that we will make.

PUBLIC HEARINGS AND APPEALS: (Began at 5:56 p.m.)

This is the date set for hearing the appeal of Warren G. Backman and Ralph Grinnell representing affected neigbors relative to site plan approval and reclassification of the property located on the southeast corner of North 37th and Pearl Streets from an "R-2" One-Family Dwelling District to an "R-3PRD" Planned Residential Development District to allow the construction of 187 multiple-family units. (REM Development Co.: File Nos. 120.1289-127.0295)

Council Member Warnick indicated to Council and all citizens that he has resided at 4412 North 37th, which is located between Stevens and Verde, for approximately 25 years. He said that on the advise of the City attorneys he understands the Appearance of Fairness Doctrine applies and that it is necessary that he absent himself from discussion on the particular matter before us at this time. Council Member Warnick announced that he would abstain from consideration of this matter and left the Council Chambers.

Deputy Mayor Stenger said that he has received numerous pieces of mail and correspondence on this particular project and, because we can only decide this matter based on the record that we have before us, the record created before the Hearing Examiner, that this correspondence that he received has no effect on the decision he was making and does not believe it prejudiced him in any way in deciding this case.

Council Members Nielsen, Moss, and Evans stated likewise.

Council Member Miller said he would likewise echo the comments of Deputy Mayor Stenger but would also like to disclose that he had had telephone conversations with the appellants prior to the appeal being made but he did not feel that would in any way prejudice his decision.

Mayor Vialle stated that she had the same declaration to make. That she has had discussion and indicated that they couldn't discuss it until this point and she didn't feel that it would prejudice her disposition of this case.

Mayor Vialle explained the rule relative to appeals before the City Council.

Rod Kerslake, Hearing Examiner, reviewed the facts of the appeal for the Council.

Mr. Jim Cochran, representing the neighborhood, stated the reasons for the appeal.

Mr. Bill Lynn, attorney representing REM Development Company, made a presentation to the Council with regard to the appeal.

Deputy Mayor Stenger moved to concur in the Findings, Conclusions and Recommendations of the Hearing Examiner and deny the appeal. Seconded by Council Member Moss. Council Member Nielsen moved to amend Condition N of the Hearing Examiner's report, although it has been stated orally that the signal proposed to be installed at North 37th and Pearl would be both vehicle and pedestrian actuated the terms of the condition of the Examiner's approval specifically state a vehicle actuated signal and he moved that the words "and pedestrian" be inserted. Seconded by Mayor Vialle. Voice vote was taken and carried, with Council Member Evans voting Nay. The motion was declared adopted.

Voice vote was taken and carried. The appeal was denied.

Mayor Vialle asked if we had information in there on the options provided us under the new transportation funding.

Mr. Corpuz said we don't have it specifically attached but we can have that available.

Mayor Vialle said a delegation from the parking garage owners came in today to discuss that option with us and she would like to have, if possible, someone to lay out those options for such a street utility and that those were also potential things for designated street and arterial improvements.
