Gary Sullivan, Hearings Examiner, made a presentation on the reclassification request of Teamsters Credit Union and outlined the basis of the appeal.

Deputy Mayor Nielsen disclosed that he is a member of the Teamsters Union and shop steward in the office where he works. He is not an officer of the Union nor a member of the Credit Union. He stated that his associations with this organization would not impair his judgement and he intended to participate in this matter.

Glenn McLean of 10414 Delwood Drive spoke on why he was appealing the reclassification.

Robert Noel, Manager of Teamsters Credit Union at 221 South 28th Street spoke on the reclassification request.

Deputy Mayor Nielsen moved that the appeal be denied and the Findings, Conclusions and Recommendations of the Hearings Examiner be concurred in Seconded by Councilwoman Bichsel. Voice vote was taken and carried.

Deputy Mayor Nielsen asked the City Manager to have the Public Works Department investigate the possibility of installing a stop sign at 28th and "C" Streets and report back to the City Council on this matter.

COMMENTS AND COMMITTEE REPORTS BY MEMBERS OF THE CITY COUNCIL:

Deputy Mayor Nielsen discussed his vote on Resolution No. 27254 regarding the mothballing of WPPSS Plant Nos. 4 & 5. At the City Council meeting of January 12, 1982 he originally voted for the Resolution and then changed his vote to Nay to be on the prevailing side for procedural and parlimentary reasons. He then instructed the Clerk to change his vote to Aye for the record.

Councilman Hyde moved to excuse Councilman Rasmussen from next weeks meeting. Seconded by Councilwoman Bichsel: Voice vote was taken and carried.

Councilman Rasmussen moved to cancel the Council meeting of March 2, 1982 as most members of the Council will be attending a convention of the National League of Cities. Seconded by Councilman Kirby. Voice vote was taken and carried.

Councilman Hyde introduced a draft of a letter to be sent to Pierce County Legislators regarding METRO's proposed sewage outfall at Seahurst Park. Councilman Hawkins moved that the letter be sent to the Pierce County Legislators. Seconded by Councilwoman Bichsel. Voice vote was taken and carried.

Mayor Sutherland moved to recess into Executive Session for the purpose of discussing personnel matters. Seconded by Councilman Rasmussen. Voice vote was taken and carried. Council recessed into Executive Session at 7:02 p.m. and reconvend at 8:05 p.m.

Mayor Sutherland called the meeting back to order at 8:05 p.m. He discussed the deliberations of the Appointments Committee and said that the City Council has reduced the list of Council candidates to ten names. The candidates will be interviewed at the conclusion of the City Council meetings on January 26, 1982 and February 2, 1982. The interviews will be televised.
