<u>Department et al.</u> United States District Court Cause No. C95-5099 FDB. Seconded by Council Member Silas. Voice vote was taken and carried. The motion was declared adopted.

REPORTS BY CITY MANAGER

City Manager Ray E. Corpuz, Jr., stated that the City of Tacoma's Sister City of Davao sent a delegation of 35 people to Tacoma on a trade mission. He stated that in that group were people from the private sector and five city council persons. Mr. Corpuz stated that the delegation signed an agreement with Bates Vocational Technical College to provide training directly to the City of Davao via teleconferencing. He stated that they were still working on other opportunities and would be visiting six other cities. Mr. Corpuz then stated that the Mayor had suggested that March 1998 would be a good time to visit the City of Davao and consummate some additional trade opportunities and investments. He stated that the City of Davao has its annual celebration of sisterhood in the second week of March.

COMMENTS AND COMMITTEE REPORTS OF CITY COUNCIL

Council Member Silas stated she was deeply saddened by recent incidents especially the death from a drive by shooting of Cory Pittman. She expressed her sympathy to the Pittman family. She also mentioned the incidents of the rape of a nine-year-old girl and the allegation of police harassment, which the City of Tacoma is investigating. She stated that as we try to make Tacoma a livable city, there are some areas that we need to take a look at as far as the betterment of our city.

Council Member Kirby moved to excuse Council Members Miller and McGavick from tonight's meeting. Seconded by Council Member Silas. Voice vote was taken and carried. The motion was declared adopted.

Council Member Kirby requested a complete report regarding the allegations of police harassment.

Council Member De Forrest stated that last Saturday he had attended the "1st year Celebration" of the Samoan American Community Services that was held at the East Side Community Center. He stated the guest speaker was Congressman Eni F. H. Faleomavaega from America-Samoa. He stated that the Salishan community should be very proud of their outstanding youth and their organizations in our community.

Deputy Mayor Baarsma extended his sympathies to the family of Cory Pittman. He stated that he hoped the Police Department can apprehend the individuals who perpetrated this tragedy.

Deputy Mayor Baarsma stated that he had received several letters and telephone calls regarding the closure of the Point Defiance Senior Center. He requested staff to respond to the letters and report back to the City Council as to what is being done regarding this issue.

Council Member Evans said he would add his letters to the same file and would also like responses to his letter and phone calls.

Mayor Ebersole stated that he and Council Member De Forrest had represented the Council at a meeting on the Eastside, in which discussions were held on how the community can encourage more economic activity on the Eastside. He stated the meeting was well attended and he believed good things would come from it.

Mayor Ebersole stated that he had welcomed delegations from the Philippines and Vietnam this week. He stated that the City of Tacoma is receiving visitors from throughout the world on a weekly basis.

Mayor Ebersole then extended his sympathy to the Pittman family and to the other family on the Eastside who had experienced the tragedy of homicide over the weekend, as well.

On proper motion, the meeting was adjourned at 9:22 p.m.
