Mayor Sutherland stated that this appeal has been withdrawn by Mr. MacDiken and no action is needed by the Council.

Mayor Sutherland stated that the appellant has been called out of town and has requested that the appeal be continued until October 27, 1987, and he so moved. Seconded by Council Member Warnick. Voice vote was taken and carried. The appeal will be rescheduled to the Council meeting of October 27, 1987.

# COMMENTS AND COMMITTEE REPORTS OF CITY COUNCIL:

Council Member Stenger stated that Council Member Mykland had requested that he inform the Council with regard to the demolition of Municipal Dock Building they had spoken with Mr. Ben Thompson of the Public Works Department to consider a possible contract with people who have already looked into the building. Apparently we would be able to have a consulting contract finished by the meeting of September 22, 1987.

Council Member Hyde said he has not seen any information with regard to the hazardous waste bill and testimony given before the select legislative committee. He stated he didn't think that a member of the Council had the right to express an opinion as though it were the consensus of the whole Council.

Mayor Sutherland said he would provide Council Member Hyde with the information he requested.

Council Member Hyde asked that the Mayor send out a letter tomorrow stating that the statement was not the official position of the City of Tacoma. The <u>Mayor</u> said he was not willing to do that unless the whole Council sat and discussed it and insisted that that be the position of the Council.

Mayor Sutherland stated that on the abatement issues he would like them to be identified on the attachment to the Resolution by item number under normal addresses. Council Member Moss said that it would also be helpful if they would identify them by item or address on the video tapes.

Council Member McElliott said that fire hazards do recur in the same areas year after year and the same people are uneasy. Just because a property has been there a long time doesn't necessarily make it a forgiving issue -- the hazard is still there. Everything is wonderful once the rain comes but the problem recurs during the dry season. She stated that she wanted to go on record that when the staff goes through the proper motions she didn't think it was correct to delete numerous items.

Mayor Sutherland moved to recess to Executive Session to discuss litigation, the session not to exceed 30 minutes. Seconded by Council Member Nielsen. Voice vote was taken and carried. The motion was declared adopted.

Council recessed to Executive Session at 6:31 p.m. and reconvened at 7:01 p.m.
