Councilman Evans moved that the hearing on the appeal of the SHERWOOD VILLAGE be placed as the first item on the Regular Agenda for March 13th. Seconded by Councilman Kirby. Voice vote was taken and carried.

Mayor Parker asked that a resolution be prepared that would place appeals immediately following the Consent Agenda.

COMMENTS AND COMMITTEE REPORTS BY MEMBERS OF THE CITY COUNCIL:

Mayor Parker advised that an inquiry has been made by TelePrompter to ascertain the City's interest in utilizing the City's Channel 8 to carry live coverage of the United States House of Representatives. This coverage would be provided by a non-profit organization called C-SCAN with no cost to the City. He said he would like the City to proceed to augment this service and work out suitable arrangements with Station KTPS so that the proceedings could be shown to the public and whatever other time is available could still be used for teachers programming. The C-SCAN coverage would begin at 9:00 a.m. Pacific time and would continue until the close of the session for that day. He asked the City management to see what arrangements could be worked out to allocate that portion of the City's channel for that purpose.

Mayor Parker also advised that for the last two days flags in the City have been flying at half mast in honor of former Mayor Harry Cain who died recently in Florida.

On proper motion the meeting adjourned at 6:55 p.m.
