Amending Chapter 13.10 of the Official Code to limit covered moorage in the City Waterway Shoreline District and establish additional administrative procedural changes.

Councilman Hyde moved that the Ordinance be amended by deleting Subsection B.10, which proposes to place a limit on the amount of covered moorage in City Waterway. Seconded by Councilman Strege. Voice vote was taken and carried. The motion was declared adopted.

Councilman Hyde moved that deleted Subsection B.10 be referred back to the Planning Commission with direction to review each individual Shoreline District in the City where marinas are allowed. In each case they should determine where possible view and aesthetic factors are of primary concern, as opposed to where market considerations and economics should be given priority consideration. The Planning Commission should also look at the possibility of giving the Hearings Examiner additional latitude and/or criteria in which to examine each individual covered moorage proposal. The Hearings Examiner could then determine, based on the facts at hand, whether or not covered moorage should be allowed and determine further the proper amount and design. Councilman Hyde then moved that the Ordinance be passed as amended. Seconded by Deputy Mayor Nielsen. Voice vote was taken and carried. The motion was declared adopted.

Cheney Foundation, \$10,000.00 from Allied Arts of Tacoma, and \$500.00 from Tacoma Firefighters Union No. 31; transferring the sum of \$10,000.00 from the General Fund Non-departmental to the Miscellaneous Grants Summary Fund; and appropriating the sum of \$47,450.00, or so much thereof as may be necessary, from the Miscellaneous Grants Summary fund for public art projects.

Mayor Sutherland stated that he had received a letter from the Tacoma section of the American Society of Civil Engineers, which stated that the Tacoma Dome had been selected for the Pacific Northwest Council 1983 Outstanding Civil Engineering Achievement Award.

Mayor Sutherland commented on a letter received from Washington Fair Share, which invited the Council to a meeting at the Sixth Avenue Baptist Church on October 12, 1983. He further indicated that he disagreed with some of the statements made by Fair Share.
