Resolution No. 35153

Authorizing the submittal of an application to the United States Department of Housing and Urban Development, Healthy Homeowners and Lead Hazard Control Fund, in the amount of \$375,000, to assist approximately 50 low-income homeowners with the cost of complying with lead-based paint regulations.
